
**Subject: Deputation of staff within Indian Audit & Accounts Department**

Madam/Sir,

In continuation of the policy for deputation of staff within IA&AD, circulated vide letter No. 60-Staff(App)-I/14-2023 dated 27.01.2025, following additional instructions are issued:-

- a. The Cadre Controlling Authorities may initially approve deputation of officials for a period of five years, if it is received along with NOC/consent of the borrowing office;
  - b. Deputation beyond 05 years upto 07 years on yearly basis will be considered by DG (Staff) for approval on case to case basis; and
  - c. However, the tenure of deputation once approved shall not be taken for granted and the official on deputation is liable to be repatriated back if his/her performance and conduct is not up to the mark, to the satisfaction of the borrowing authority, or for other administrative reasons.
