Subject: Grant of dearness relief with effect from 01-07-2021, 01-01-2022, 01-07-2022, 01-01-2023 and 01-07-2023 on pre-revised pension/family pension in respect of pensioners/family pensioners coming under the category of Kerala State Judicial Officer.

In continuation to this office circular No. Pen. Co-ordn./Kerala/Vol.VIII/DR-Judi/172 dated 24-02-2022, it is reminded that as per standing order of the Government of Kerala issued under GO Ms. No. 55/2011/Home dated 24-02-2011 (circulated under this office No. Pen. Co-ordn./Kerala/Vol.VII/DR&PTCont./226 dated 03-02-2012) pensioners/family pensioners coming under the category of Kerala State Judicial Officers are entitled to get dearness relief on their pre-revised pension/family pension, i.e. who are drawing pre-revised pension/family pension as per recommendations of Padmanabham Committee and as accepted by the Hon'ble Supreme Court of India. Accordingly, dearness relief admissible on the pension/family pension of such pensioners @ 196% with effect from 01-07-2021, @ 203% with effect from 01-01-2022, @ 212% with effect from 01-07-2022, @ 221% with effect from 01-01-2023 and @ 230% with effect from 01-07-2023 as per Government of India, Ministry of Finance, Department of Expenditure OM Nos. 1/3(1)/2008-E.II(B) dated 01-11-2021, 1/3(1)/2008-E.II(B) dated 07-04-2022, 1/3(1)/2008-E.II(B) dated 12-10-2022, 1/3(1)/2008-E.II(B) dated 10-04-2023 and 1/3(1)/2008-E.II(B) dated 06-11-2023 respectively.

- 2. Having been authorized by the office of the Accountant General (A&E), Kerala in their authority Nos.
