CIRCULAR

Sub Willingness from eligible fresh / repeater candidates intending to appear at the ensuing CPD-I, CPD-II and CPD-III Examination-I & II of 2025 and avail the online Pre-examination training.

It has been decided by Headquarters Office to provide Pre-Examination Training to Sr. AOs / Sr. DAOs/AAOs/DAOs Gr I for appearing CPD Examination I, II of 2025. In this connection Training Wing of Headquarters office has requested to compile the list of eligible and willing SAOs/ Sr. DAOs/ AAOs / DAOs Gr.I for the pre-examination CPD training for the year 2025. Further, it is instructed to complete the online training by 10th May 2025. Hence, we may request eligible and willing officers for the said CPD Pre-Examination Training to submit their willingness latest by **26.03.2025**.

The Sr. AOs / AAO fulfilling the following criteria are eligible for the proposed training.

- The pre-examination training for CPD examination will be conducted online only.
- The pre-examination training is voluntary.
- The CPD Pre-examination training will be conducted only once in a year for both the examinations i.e. Examinations-I and II of respective year.
- The pre-examination training for CPD examination is to be provided only once for each stage of CPD Examination i.e. once for CPD-I examination, once for CPD-II examination and once for CPD-III examination.
- The officers who have attended the pre-examination CPD training conducted online in the year 2022 and 2023 are not considered for nominations for the said training.
- SAOs / Sr. DAOs / AAOs/ DAOs Gr-I who are eligible as on 1st March 2025 for Examination 1 of 2025 and those who are eligible as on 1st September 2025 for Examination-2 of 2025 should only be considered for nomination for the said training.

The following SAOs / Sr.DAOs / AAOs/ DAOs Gr-I are eligible for taking the proposed training and appear the CPD-I Examination (both Exam-I and Exam-II of 2025).

1. All SAOs / Sr. DAOs are eligible to take the first CPD test.
2. All AAOs would be eligible to appear in the first CPD test after completion of four years continuous service in the grade as on the 01.03.2025/01.09.25 as the case may be.

Similarly, the following SAOs / Sr.DAOs / AAOs/ DAOs Gr-I are eligible for taking the proposed training and appear the CPD-II Examination (both Exam-I and Exam-II of 2025).

All SAOs / Sr. DAOs / AAOs/ DAOs Gr-I who have completed four years as on 01.03.2025 and 01.09.25 since the date of their qualifying the CPD-I Examination.

Hence, all eligible SAOs / Sr. DAOs / AAOs/ DAOs Gr-I of the Office of the Principal Accountant General (A&E), Odisha, Bhubaneswar including Branch Office, Puri intending to avail the proposed training program and appear in the above examinations scheduled in 2025 may submit their application to Training and Examination Section (trgexam.odi.ae@cag.gov.in), duly filled in, in the prescribed pro-forma which can be downloaded from the office website (<https://cag.gov.in/ae/odisha/en/ae-circulars-office-orders?cat=853>) latest by **26.03.2025**. Applications received after due date or in incomplete shape will be rejected.

The starting date for calculating the required length of service for officials on Mutual Transfer should begin from the date of joining in the New Office.

The officers who have availed the pre-examination CPD training conducted online in the year 2022, 2023 and 2024 are not eligible for the said training.


