Sub-Willingness for Pre-Examination training of CPD Exam I & II of 2025.

In terms of Headquarters Office, Knowledge & Capacity Building Wing Circular No. 388 dated 18.03.2025, a pre-examination training will be organised by various RCBKIs/RCBKCs/NAAA/iCISA for the eligible and willing candidates appearing for CPD Examination I/II/ III of Examination I & II of 2025 in online mode. The training will be conducted only once in a year for both the examinations i.e. Examination I & II of the respective year and participation in the training is voluntary. The training is to be provided only once for each stage of CPD examination (I/II/III) in the career of an officer.

The eligible SAOs/AAOs who are willing to attend the said training and fulfil the following conditions may submit their willingness in the prescribed proforma through proper channel to Trg. & Exam Section latest by 26th March 2025.

- ➤ Officers who have attended the online pre-examination CPD training conducted earlier in the year 2022 to 2024 are not eligible to apply.
- The SAOs/AAOs who meet eligibility criteria as on 1st September 2025 for appearing Exam 2 of 2025 would be considered for the training.

All Controlling Branch Officers are requested to forward the applications of eligible and willing candidates to Trg. & Exam Section by due date. Applications received after due date or incomplete will not be considered for the online training.
