The Financial up-gradation is subject to the following condition:

- 1. The financial up-gradation shall be purely personal to the employee and shall have no relevance to his seniority position. As such there shall be no additional financial up-gradation for the senior employee on the ground that the junior employee in the grade has got higher pay scale under the MACP scheme.
- 2. Placement in the higher grade under financial up-gradation of MACPS does not amount to functional/regular promotion from the date of MACP.
- 3. Financial benefit allowed under the MACP scheme shall be final and no pay fixation benefit shall accrue at the time of regular promotion i.e., posting against a functional post in the higher Level except difference of pay, if any in promotional post.
- 4. Grant of higher pay shall be conditional to the fact that an employee, while accepting the said benefit shall be deemed to have given his unqualified acceptance for regular promotion on occurrence of vacancy subsequently.
- 5. The financial up-gradation does not confer any privileges related to higher status (eg. Invitation to ceremonial functions, deputation to higher posts etc.) but is restricted to other benefits like HBA, allotment of Govt. accommodation, advances etc.
- 6. The officials are required to exercise an option for fixation of pay under FR-22 (I) (a) (1) within one month from the date of issue of these orders.
