## परिपत्र/CIRCULAR

सरकारी क्वार्टरों को बनाए रखने के संबंध में मौजूदा दिशानिर्देशों के अनुसार, यह सूचित किया जाता है कि आईएएंडएडी पूल, भुवनेश्वर के तहत सेवानिवृत कर्मचारियों को सेवानिवृत्ति की तारीख से अधिकतम छह महीने की अविध के लिए अपने आवंटित क्वार्टर को बनाए रखने की अनुमति है।

छह महीने की अनुमेय अविध से अधिक किसी भी विस्तार के लिए कोई छूट नहीं दी जाएगी और आवंटित क्वार्टरों के अनिधकृत प्रतिधारण अविध के लिए सामान्य लाइसेंस शुल्क (एचएलएफ) के 40 गुना की दर से क्षिति शुल्क लगाया जाएगा।

हालांकि, गंभीर चिकित्सा बीमारी के मामलों में, सामान्य लाइसेंस शुल्क पर अनुमेय अविध से परे दो महीने की अतिरिक्त अवधारण अविध दी जा सकती है। यह विस्तार सहायक चिकित्सा दस्तावेजों और बीमारी की प्रकृति और गंभीरता की पुष्टि करने वाले उचित साक्ष्य प्रस्तुत करने के अधीन होगा। सभी संबंधितों से उपरोक्त निर्देशों का पालन करने का अनुरोध किया जाता है।

In accordance with the prevailing guidelines regarding the retention of government quarters, it is hereby informed that retired employees under the IA&AD Pool, Bhubaneswar, are permitted to retain their allotted quarters for a maximum period of six months from the date of retirement.

For any extension beyond the permissible period of six months, no exemption will be granted and damage charges will be levied at the rate of 40 times the normal license fee (HLF) for the unauthorized period of retention of the allotted quarters.

However, in cases of serious medical illness, an additional retention period of two months beyond the permissible period on normal license fee may be granted. This extension will be subject to the submission of supporting medical documents and proper evidence verifying the nature and seriousness of the illness.

All concerned are requested to comply with the above instructions.
