Examination wing at Hqrs office vide letter No. 150/14- Exam/SASetcExam/ 2025 dated: 15.04.2025 has intimated that the SAS/RA/I/CPD-I, II & III examinations of Examination-1 of 2025, will be conducted from **20.05.2025 to 26.05.2025**.
