

Office Order

The SAS/I/CPD-I, II & III Examination-1 of 2025 is scheduled to be held from 20th May to 26th May 2025 as per the Headquarters Office (Examination Wing) letter No. 150/14-Exam/SAS etc Exam/2025 dated 15.04.2025. The date sheet of examination will be notified in due course after receiving from the headquarters office.

The registration for the SAS/I/CPD-I, II & III Examination-1 of 2025 will commence from 17th April 2025 and end on 28th April 2025. The cut-off date for eligibility for the examination is 1st March 2025.

Only existing departmental candidates and all DRAAOs will be allowed to appear in the SAS Exam – 1 of 2025. This SAS Exam-1 of 2025 is the last exam in the existing syllabus. SAS Exam-2 of 2025 will be held in revised/new syllabus.

All eligible candidates (fresh/existing) are allowed for Incentive/CPD-I, II & III Examination-1 of 2025.

The chance of a candidate would be counted once she/he registers and there is no scope for withdrawal.

The registration process in Gwalior office will be completed in Confidential Cell and at Bhopal Branch this will be completed under the supervision of the Deputy Accountant General (Works & Accounts) with the assistance of Senior Accounts Officer/Admn. Deputy Accountant General (Admn.) is Examination Registration Officer (ERO).

The intending candidates may submit their application in the prescribed proforma duly completed in all respects latest by 25th April 2025. The applications received after the stipulated date shall not be entertained in any case.

The officials on deputation to other offices within the department (IA&AD) and other departments may also submit their applications directly to this office up to 25th April 2025 with the intimation to Administration of borrowing office and all examination related communication may be made with the parent department (Sr. A.O./C.C.) for timely completion of registration process/other examination related issues.



The SAS/RA/I/CPD-I, II & III Exam -1 of 2025 will be held from **20th to 26th May 2025**. The date sheet of the examination will be intimated in due course. The registration for existing departmental candidates & all DRAAOs for SAS Exam-1 of 2025 & all candidates (fresh/existing) for RA/Incentive/CPD-I, II & III Exam-1 of 2025, will commence from 17.04.2025 and will end on 02.05.2025. The cut-off date for eligibility for the examination is 1st March 2025.

2. The competent authority had decided that only **existing departmental candidates and all DRAAOs** will be allowed to appear in the SAS Exam-1 of 2025 as was earlier communicated to all HoDs vide Exam Wing's letter No. 104/06-Exam/OCDEP/2025 dated 11.03.2025. The existing candidates will appear in the existing branch only.

3. SAS Exam-1 of 2025 is the last exam in the existing syllabus. From SAS Exam-2 of 2025, revised/new syllabus of SAS exam will be implemented.

4. All HoDs may nominate a Group Officer as Examination Registration Officer (ERO) to manage and supervise the registration process. The basic data i.e. Name, DoB, Category etc as mentioned in Service Books of the new candidates (*DRAAOs for SAS & RA/Incentive/CPD candidates*) will be entered into the first part of the Registration Form by the ERO. Thereafter, the fresh candidates will complete the second part (exam details) of the Registration Form by themselves. The existing candidates will fill up the second part of the Registration Form after activation by the ERO. The ERO will verify and validate the data entered into the online registration Forms to enable the HoD to approve their candidature. The onus of correctness of eligibility and data will be completely on the field offices. The registration process including ERO validation/HoD approval may be completed as soon as possible but latest **by 02.05.2025**. Chance of a candidate would be counted once she/he registers and there is no scope for withdrawal.

5. The officials who are on deputation to other offices within the department may submit their willingness /application directly to their parent offices under intimation to Administration branch/section of the borrowing offices. Such candidates will make all

examination related communication with their parent offices directly, for timely completion of registration process/other examination related issues.

6. The link for Registration and user id & password of ERO & HoD for registration/validation/approval will be the same which was used in the previous SAS/RAI/CPD-I, II & III Exam-1 of 2024.
