Senior Auditors / Assistant Supervisors (who have not passed the Incentive Examination as Senior Auditors) with one year of continuous service in the grade as on 01.04.2025 and who have not reached the maximum in their pay scale are eligible to appear in the examination. The examination should be written without the aid of books. The Exam will be conducted in Multiple Choice Questions (MCQ) pattern and Negative marking to the extent 0.25 marks (25 percent). Candidates have the option to answer the paper either in Hindi or in English.

Candidates should secure a minimum of 50% marks to qualify in the examination. Candidates who qualify in the examination will be granted one advance increment from the first day of the month in which the examination is held.

Senior Auditors / Assistant Supervisors of the Offices of the Principal Accountant General (Audit I), Tamilnadu, the Principal Accountant General (Audit II), Tamilnadu & Puducherry and the Director General of Audit (Central), Chennai, who fulfil the eligibility criteria and wish to appear for the said Examination may submit their applications with the recommendation of the Branch Officer to Administration II Section of this Office on or before **07.04.2025**.
