OFFICE ORDER

In pursuance of point (xiv) under Para 13 of DoPT's OM No. F.No. 14014/1/2022-Estt. (D) Dated 02.08.2022 regarding Master Circular on Scheme of Compassionate Appointment, the minutes of the meeting duly signed by all the members of the Departmental Screening Committee who met on 12.06.2025 for adjudging 01 application and the merit points earned by the applicant, is appended herewith.

Minutes and Recommendations of the Meeting of the Departmental Screening Committee for appointment on Compassionate Ground held on 12.06.2025

The Departmental Screening Committee (DSC) consisting of Ms Aditi Sharma, Director (Admn), O/o the Director General of Audit, (Central), Kolkata, Shri Arun Minj, Director (Admn), O/o the Principal Director of Audit, Eastern Railway, Kolkata and Shri Shambhu Dayal, Deputy Accountant General (Admn), O/o the Accountant General (A&E), West Bengal met on 12.06.2025 for adjudging the suitability of 01 (one) application for appointment on compassionate ground in Group 'C' cadre which was received during the period from 01.07.2024 to 31.12.2024.

2. The Committee was informed that available vacancies as on 01.01.2025 for compassionate appointment in Gr- C cadre are one (01) in the cadre of Accountant, 01 in the cadre of Data Entry Operator (Grade A), two (02) in the cadre of Clerk and six (06) in the cadre of MTS, which was approved by the Competent Authority. Accordingly the calculations of the same are given below along-with the details of each of the post.

3. The Committee was informed that as per recruitment rules in IAAD, the age, educational and other qualification for the available post for the compassionate appointment are as under:

- 4. The committee deliberated on the issue of eligibility for consideration for appointment on compassionate ground and related issues as per existing guidelines and court rulings communicated under Headquarters circular no 130/ Staff (Entt)(Rules)/A.R/02-2021 dated 24.08.2022 in congruence with the DoPT's OM No. 14014/1/2022- Estt(D) dated 02.08.2022.
- 5. The Committee perused one (01) application which was initially submitted vide letter dated 05.07.2024 by Shri Sayan Sarkar, s/o the deceased employee, Late Upendra Nath Sarkar, ex-Senior Accountant followed by another letter dated 06.03.2025. Further, the verification report of the Sr. Accounts Officer (Welfare) as well as other relevant records in respect of the applicant and the matrix evaluation sheet of the applicant as prepared in accordance with Headquarters Office Circular No. 14 dated 20.04.2022 were examined by the Committee.
- 6. The details of the applicant are given below:

7. The relevant provisions of DoPT OM dated 2ndAugust 2022 on the Scheme for Compassionate Appointment as enunciated below are considered by the Committee in respect of the instant case.

- Para 1: The object of the Scheme is to grant appointment on compassionate grounds to a dependent family member of a Government servant dying in harness or who is retired on medical grounds, thereby leaving his family in penury and without any means of livelihood, to relieve the family of the Government servant concerned from financial destitution and to help it get over the emergency.
- Para 5 (a): The family is indigent and deserves immediate assistance for relief from financial destitution.

Relaxation

*

The upper age limit could be relaxed wherever found to be necessary. The lower age limit should, however, in no case be relaxed below 18 years of the age. However, age eligibility shall be determined with reference to the date of application and not the date of appointment. Further, authority competent to take a final decision for making compassionate appointment in a case shall be competent to grant relaxation of upper age limit also for making such appointment.

8. Observation of Committee:

The committee observed the following points in respect of the case and keeping in view the objective of the Compassionate appointment, recommends as under:

Shri Sayan Sarkar (unmarried major son of Late Upendra Nath Sarkar, ex- Sr Accountant):

The family received terminal benefits amounting to Rs. 29,35,776/- (excluding G.P.F. amounting to Rs 25,80,462/-). The family is getting an enhanced family pension @ Rs. 32,050/- p.m. (excluding DR) from 08.11.2023 to 07.11.2033 and thereafter at normal rate @ Rs. 19,230/- (excluding DR) w.e.f. 08.11.2033 per month. It is observed that the deceased had more than 4 years of service left at the time of his death. The deceased government servant is survived by his widow and only son i.e. the applicant who is 25 years 10 months old as on date of the application dated 05.07.2024 and both the family members are unemployed as per the letter dated 20.08.2024.

As per the report of the Sr. Accounts Officer(Welfare) dated 11.03.2025 produced before the Committee, the family members are living in their own ancestral house located at Rabindra Sarani, South Durganagar, Block- North Dum Dum (M), Kolkata- 65. The house is a two storied building measuring build up area 1395 sq ft which consists of 4 bedrooms measuring (16 Ft x 12 Ft.) for each of two bedrooms and (14 Ft x 12 Ft) approx for each of the rest two bedrooms with a dining room (25 Ft x 15 Ft) and three toilets and two kitchen as well as a small balcony. As per the report furnished by the Sub Divisional Officer, Barrackpore , North 24 Parganas on 24.02.2025, the present market value of the property as mentioned above is Rs 33,86,950/-. Total present financial liability on the family is Rs. 2,00,000/- only.

The committee assessed the case in an objective and balanced manner with due consideration of the financial condition of the family including the terminal benefits, assets, liabilities. The committee observed that the family is not in any financial distress or living in such a state of penury that it deserves immediate assistance in the form of Compassionate appointment for relief from financial destitution to get over the emergency, as envisaged in the objective of the compassionate appointment.

Recommendations of the Committee

The applicant has scored 55 matrix points out of 180 as per the prescribed evaluation sheet in terms of Headquarters' Circular No.14 dated 20.04.2022. Considering the above and keeping in view that the main objective of the compassionate appointment is to primarily help the family of the deceased employee to tide over the economic distress and hardships, the DSC recommends that the applicant is "NOT FIT" for compassionate appointment.

The Committee certifies that "none of our close relative is being considered by the Departmental Screening Committee constituted for the purpose of considering the application for appointment under compassionate ground in the Office of the AG (A&E), West Bengal, Kolkata and that otherwise also they are not interested in any particular candidate".
