It was informed to the Committee that there is only one application, i.e., of Ms. Moumita Sarkar, pending as per the return sent to Headquarters' Office on 23.04.2025 in compliance of Circular 14 on compassionate appointment.

The Committee was informed that in terms of Master Circular issued by DoPT, Ministry of Personnel, Public Grievances and Pensions, Govt. of India vide O.M. F.No. 14014/02/2022-Estt (D) dated 02.08.2022 received with Headquarters' Office letter No. 125- स्टाफ हकदारी (नियम) / ए.आर/02-2021 दिनांक 05.08.2022, compassionate appointments may be made upto a maximum of 5% of vacancies falling under direct recruitment quota in any Group 'C' post. The Committee was apprised that there are 06 (six) vacancies in Group 'C' cadre for the panel year 2025 for appointment on compassionate ground in the Offices of the Principal Accountant General (Audit-I) West Bengal (cadre controlling office) and Principal Accountant General (Audit-II), West Bengal as detailed below:


Earlier, the Committee met on 29.05.2025 and after examining the application and scrutinizing all relevant documents/ records in this regard, the Committee asked for few more supporting documents/ information to get a more vivid picture of the financial conditions of the family.

The Committee took note of the Physical Inspection Report dated 02.05.2025 submitted by Sr. Audit Officer (Welfare) and other official records and the following points in respect of the application of Ms. Moumita Sarkar, wife of Late Goutam Sarkar, Auditor has come to light:

- Late Goutam Sarkar expired on 27.05.2023 after 45 days of hospitalisation due to an unfortunate motorcycle accident occurred on 14.04.2023. His age was 50 years at that time.
- He was survived by four family members as mentioned below:
 - i) Ms. Moumita Sarkar (age 39 years) – Wife
 - ii) Ms. Subarnakshi Sarkar (age 15 years) – Daughter
 - iii) Mr. Gobinda Sarkar (age 76 years) – Father (Dependant)
 - iv) Ms. Jogmaya Sarkar (age 66 years) – Mother (Dependant)
- The above mentioned family members are fully depended upon the family pension which is the only financial source for livelihood. None of the family member is earning.
- The financial implication of education of the minor daughter studying in Class XI and medical expenses of the aged parents.

- Ms. Moumita Sarkar had received terminal benefits of Rs. 29,34,025/- (DCRG + Leave Encashment + CGEGIS + GPF)
- As per the declaration by Ms. Sarkar and Welfare Officer's report, she is residing at Barrackpore at a rental house to support her daughter's education, who is pursuing her class XI studies. At the same time, Ms. Sarkar is supporting her in-laws household at Natapuli, Chakdaha, District Nadia, West Bengal. The total monthly expenditure of the family is more than the family pension as detailed below:

- Besides, there are no other earning member in the family, hence, the family is in the need of adequate financial backing to support the above finances.
- Ms. Moumita Sarkar (DOB – 08.05.1986) had earlier applied for appointment on compassionate ground in the prescribed proforma dated 24.06.2024 which was rejected by the Competent Authority and subsequently applied again vide her application dated 29.10.2024 which is presented before the present Committee.
- The applicant Ms. Moumita Sarkar holds degree of Bachelor of Arts from University of Kolkata.
- The applicant has been awarded 95 marks out of total 165 in the revised Evaluation sheet (Annexure-V(ii)) copy of which is enclosed.

In view of the above points and considering the educational qualification of the applicant and that the family is in need of immediate financial relief/support to take care of the basic expenses of the family members, the Committee recommends the applicant, Ms. Moumita Sarkar; 'FIT' for appointment as **Auditor** on compassionate ground subject to relaxation of the upper age limit by the Competent Authority.

It is certified that, the applicant is not related to any of the Departmental Screening Committee members nor the Departmental Screening Committee members in any way are interested in the applicant.

After examining the application and scrutinizing all relevant documents/ records in this regard, the Committee has noted the following observations and asked for few supporting documents/ information to get a more vivid picture of the financial conditions of the family:

- i) As per the Service Book of Late Sarkar, both the parents are not declared as dependent, however, in terms of the Physical Inspection report prepared by the Sr. AO (Welfare) and Certificate of the Pradhan of Local Gram Panchayat, the parents are shown as dependent. The matter may be clarified further on the basis of Income Certificate in respect of the parents.
- ii) Any serious medical condition of the parents, if any, may be brought to the notice of the Committee.

- iii) The approx. monthly expenditure of the family may be prepared to understand the current financial situation of the family.
- iv) All educational Mark sheets in respect of Ms. Sarkar may be also be collected.
- v) Certificate from the School Authority regarding the academic performance of the minor daughter may be obtained to have an overview on her future educational aspects.

The Committee has decided to again meet on 12.06.2025 to consider the suitability of the compassionate appointment application of Ms. Sarkar.




