## Sub: Bridge Course for departmentally promoted Assistant Audit Officers of Commercial cadre

To strengthen the capacity building initiatives in the CAG Institution, Headquarters Office has signed a Memorandum of Understanding (MoU) with the Institute of Chartered Accountants of India (ICAI) under which two levels of certification courses i.e. entry level and advanced level have been introduced for the Officers of IA&AD.

In this regard, all the officials promoted to the post of Assistant Audit Officer in Commercial cadre since 2020 are required to complete a Bridge Course "Financial Accounting and Analysis" on basics of financial accounting available on SWAYAM portal free of cost (for learners) before their nomination for the ICAI's courses. 

Respected Sir/Madam

I am directed to invite reference to the subject cited above and to state that a Memorandum of Understanding (MoU) has been signed with the Institute of Chartered Accountants of India (ICAI) on 21.04.2025 under which two levels of certification courses i.e. entry level and advanced level have been introduced for the Officers of IA&AD in strengthening the capacity building initiatives in the CAG Institution. The first entry level certification course has been successfully conducted in ICAI's Centre of Excellence, Hyderabad during the period from 05.05.2025 to 05.06.2025 (5 weeks) in which 48 departmental promoted Assistant Audit Officers of Commercial cadre have been given training.

It is stated that most of the departmental promoted AAOs of Commercial cadre are from non-commerce background. Therefore, it has been decided that all the Officials promoted to the post of Assistant Audit Officers of Commercial cadre since 2020 are required to complete a Bridge Course "Financial Accounting and Analysis" on basics of financial accounting which is available on SWAYAM portal before their nomination for the ICAI's courses. The following are the details of the identified course:

SWAYAM courses are generally structured around a set number of weeks rather than being defined by a specific number of daily hours. While the duration of a course is measured in weeks, the time commitment per day is flexible and dependent on the individual learner and the specific course content. The video lectures hours within this course, across all modules, typically don't exceed 15 hours. Thus, this Bridge Course can be attended by the identified AAOs as per their convenience without affecting office hours significantly. As per information available in SWAYAM portal, this course is available free of cost to the learners, but the participants

who need certificate will require to write a proctored exam which has a nominal fee of Rs.750 plus GST for general candidates and Rs.500 plus GST for reserved/PwBD candidates and minimum 40% marks would be required to get the certificate for the course.

It is stated that completion of this Bridge Course would be mandatory for nomination of the future entry level courses of ICAI. However, passing the exam of the Bridge Course would not be mandatory to get nominated for ICAI's entry level course.

In view of above, all departmental promoted Assistant Audit Officers of Commercial Cadre are required to complete the Bridge Course. Therefore, it is requested to direct all departmental promoted Assistant Audit Officers of Commercial Cadre, presently working in your Office or on deputation, to enroll and complete the Bridge Course. It is also requested to send the status of completion of Bridge Course to Headquarters Office.
