Subject : Grant of dearness relief to the Manipur Government pensioners/family pensioners with effect from 01-01-2025.

In continuation to this office circular No. Pen. Co-ordn./Manipur/Vol.-V/DR/61 dated 02-07-2024, this is to state that the Government of Manipur in their Memo No. 2/6/2010-FD(PIC)(Pt) dated 24-01-2025 and Addendum No. 2/6/2010-FD-FD(PIC)(Pt) dated 09-04-2025 has sanctioned dearness relief to their pensioners/family pensioners at the rate and from the date as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-01-2025	39% of basic pension/family pension

2. The above dearness relief will also be admissible on the additional basic pension/additional family pension available to older pensioners/family pensioners based on their age.

3. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

4. Other provisions governing grant of dearness relief in respect of employed family pensioners and re-employed Manipur Government pensioners will remain unchanged.

5. Having been authorized by the Pr. Accountant General (A&E), Manipur in their authority Nos. GOE/DA/RP-2010/Auth/Part1/158 dated 07-01-2025 and GOE/DA/RP-2010/Auth/Part1/184 dated 29-01-2025, it is requested to make necessary arrangement for payment of dearness relief @ 39% on pension/family pension of Manipur Government pensioners/family pensioners with effect from 01-01-2025 as per instructions laid down above and after proper adjustment.

6. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Manipur etc."
