Applications are invited from eligible officials who are willing for appointment as Welfare Assistant (Ex-cadre deputation post) in Level-8 of Pay Matrix in the Office of the Principal Accountant General (A&E), Andhra Pradesh, Vijayawada. The period of deputation is initially for a period of **one** (1) year and the continuance in the ex-cadre posts will be based on the performance of the official and subject to sanction for continuance of the post by Head Quarters.

Eligibility Criteria:

- i. The official holding analogous posts on regular basis in the parent cadre or Department; **or**,
 - ii. The official with regular service of 3 years in the grade of Sr. Accountant or the official holding the post of Asst. Supervisor; **and**
 - iii. The official possessing three years of experience in the field of welfare or community activities, housekeeping, sports and cultural activities, personnel administration including settlement of personal claims.
 - iv. The maximum age limit for appointment by deputation shall not exceed 56 years as on closing date of receipt of application.
2. The period of deputation including period of deputation in another ex-cadre posts held immediately preceding this appointment in the same or other organization or Department of the Central Government shall ordinarily not to exceed three years.
3. Deputation Guidelines issued by HQrs vide letter no. 60- Staff (app-I)/14-2023 dated 27.01.2025 shall be strictly adhered to. The deputation allowance/ pay fixation of the said post shall be as per extant rules.
4.
