***Subject : Grant of dearness relief on revised pension/family pension of
Nagaland Government pensioners/family pensioners
with effect from 01-01-2025.***

In continuation to this office circular No. Pen. Co-ordn./Nagaland/Vol.-V/DR/141 dated 26-12-2024, this is to state that the Government of Nagaland in their FD Memo No. FIN/ROP/REL-8/87 (Vol-II) dated 05-05-2025 has enhanced the existing rate of dearness relief on the revised pension/family pension of their pensioners/family pensioners from 53% to 55% with effect from 01-01-2025.

2. Payment of dearness relief involving fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Principal Accountant General (A&E), Nagaland in their letter No. Pen/NL-DR/2023-25/232 dated 15-05-2025, followed by No. TM/SSA/24-25/168 dated 30-06-2025, it is requested to make necessary arrangement for payment of dearness relief @ 55% on revised pension/family pension of all eligible Nagaland Government pensioners/family pensioners on their basic pension/family pension with effect from 01-01-2025 after proper adjustment.

4. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Nagaland etc."
