The Knowledge & Capacity Building Wing of Headquarters Office vide email dated 14.10.2025 stated that Artificial Intelligence is increasingly being integrated into governance, auditing and service delivery functions and that though AI offers significant opportunities for efficiency and innovation, it also poses ethical, legal and social challenges. Therefore, emphasized the need to ensure the responsible and transparent use of AI for maintaining public trust and accountability.

In this connection, taking into consideration the emerging role of AI in various domains, including auditing and public administration, the competent authority has identified an online course titled "*Ethical Use of Artificial Intelligence*" on the iGOT (Integrated Government Online Training) Karmayogi portal to be mandatorily completed by all the IAAS officers and staff of IA & AD in order to equip them with the knowledge of the ethical dimensions of AI.

Further, the course provides a structured understanding of AI ethics, challenges and regulations, it covers core principles like fairness, accountability, transparency and privacy with real world examples.
