Subject: - Handling of Demonstration and Strikes – Instructions regarding.

Sir/Madam,

As per extant instructions issued from time to time in order to ensure the seamless functioning of office operations, uphold public order and safeguard the safety of employees and Government property, all forms of demonstrations, protest and unauthorized gatherings within office premises are strictly prohibited.

In continuation of the same, all HoD of IA&AD are requested to bring the contents of O.M. of Ministry of Home Affairs (MHA) issued vide OM No. 24/1/60-Ests (B) dated 25.01.1960 to the notice of all field level associations. Attention is also drawn to the Rangachari instructions, which refer to the restrictions placed on Government servants who are office-bearers of service association, specifically concerning how they deal with matters connected to their associations. In particular, attention of all officials may be drawn to the 1960 guidelines, which were later formally incorporated into the CCS (Conduct) Rules of 1964. These deal with the following:

- An office-bearer or member of an Executive Committee of a Service Association should not deal in his official capacity with any matter concerning that association.
- Demonstrations or strikes that are prejudicial to India's sovereignty, security, or public order are prohibited. This includes those that involve contempt of court, defamation, or incitement to an offense.
- Government servants are forbidden from resorting to or abetting any form of strike, coercion, or physical duress related to their service conditions or the service of other Government servants.
- Government servants are also instructed to keep away from demonstrations organized by political parties.

HoDs may also refer to instructions regarding handling of Demonstrations and Strikes issued vide this office letter No. 131-NGE (JCM)/20-2010 KW-II dated 21.02.2012 and followed by reminder issued vide letter No. 210-Staff (JCM)/03-2025 dated 23.06.2025 for ready reference.

-:: 2 ::-

It is reiterated that any Government servant engaging himself or participating in any demonstrations/meetings/dharna in violation of the above instructions and/or resorting to or in any way abetting any form of dharna, is liable for appropriate action, both administrative and/or disciplinary.

It is reiterated that instructions given in the said OM and circular, may be strictly adhered to.
