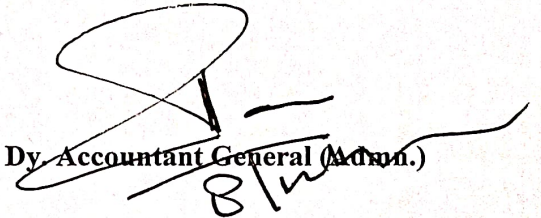
OFFICE ORDER

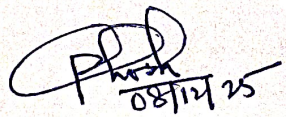
