**Subject : Grant of dearness relief to Assam Government pensioners/family pensioners/extra-ordinary pension holders/compassionate family pension holders with effect from 01-07-2025.**

In continuation to this office circular No. Pen. Co-ordn./Assam/Vol.-VIII/DR/23 dated 19-05-2025, this is to state that the Government of Assam in their O.M. No. FEG.2498/2017/418 dated 22-10-2025 have sanctioned dearness relief to their pensioners/family pensioners/extra-ordinary pension holders/compassionate family pension holders as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-07-2025	58% of basic pension/family pension

2. The payment on account of dearness relief involving fraction of 50 paise and above may be rounded off to the next higher rupee and fraction of less than 50 paise may be ignored.

3. Having been authorized by the Accountant General (A&E), Assam in their authority No. GE-1/State/DA/2025-26/2004-2013 dated 29-10-2025, it is requested to make necessary arrangement for payment of dearness relief @ 58% to all eligible Assam Government pensioners/family pensioners/extra-ordinary pension holders with effect from 01-07-2025 after proper adjustment.
