Subject : Grant of dearness relief to the Karnataka Government pensioners/family pensioners with effect from 01-07-2025.

In continuation to this office circular No. Pen. Co-ordn./Karnataka/Vol.-VI/DR/47 dated 21-07-2025, this is to state that the Government of Karnataka in their Order No. FD 18 SRP 2025 dated 15-10-2025 has enhanced the dearness relief from the existing rate of 12.25% to 14.25% with effect from 01-07-2025 on revised basic pension/family pension (under 2024 Revised Pay Scale and Revised Pension) to their pensioners/family pensioners including the pensioners/family pensioners of the Aided Educational Institutions whose pension/family pension is paid out of the Consolidated Fund of the State of Karnataka.

2. Payment of dearness relief involving fraction of 50 paise and above shall be rounded off to the next rupee and fraction less than 50 paise shall be ignored.

3. This order shall also be applicable to the retired employees who were on UGC/AICTE/ICAR Scales of pay.

4. This order shall not be applicable to retired Judicial pensioners. Separate orders will be issued in respect of those pensioners.

5. Having been authorised by the Accountant General (A&E), Karnataka in their letter No. PM/G III/2025-26/DA/SS-14632/421 dated 12-11-2025, it is requested to make necessary arrangement for payment of dearness relief @ 14.25% on revised pension/family pension of the Karnataka Government pensioners/family pensioners mentioned above with effect from 01-07-2025 after proper adjustment.

6. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Karnataka etc."
