Subject : Grant of Dearness Relief to the Haryana Government pensioners/family pensioners with effect from 01-07-2025.

In continuation to this office circular Pen. Co-ordn./Haryana/Vol.- VII/DR/37 dated 20-06-2025, this is to state that the Government of Haryana in their Finance Department Order No. 4/3/2016-5FR/22305 dated 24-10-2025 has sanctioned dearness relief on revised pension/family pension of their pensioners/family pensioners as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-07-2025	58% of basic pension/family pension

2. The payment on account of dearness relief involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.

3. All other conditions for payment of dearness relief to pensioners/family pensioners on revised pension/family pension contained in FD's instructions No. 2/23/2016-1 Pension dated 03-03-2017, as circulated under No. Pen. Co-ordn./Haryana/Vol.- VII/Revision/57 dated 04-07-2017, shall be applicable.

4. Having been authorised by the Pr. Accountant General (A&E), Haryana in their authority No. Pen-1/Gen-26/DA/2025-26/699-788 dated 30-10-2025 (SSA No. 04), it is requested to make necessary arrangement for payment of dearness relief to all eligible Haryana Government pensioners/family pensioners @ 58% on their basic pension/family pension with effect from 01-07-2025 after proper adjustment.

5. The charges on this accounts are debitable to the head "8793-I.S.S.A/cs.; Government of Haryana etc."
