As per headquarters' office Examination Wing circular No. 03 of 2025 circulated vide letter No. 612/26-Exam/SAS Etc Exam/2025 dated 19.12.2025, the SAS/RA/I/CPD-I, II & III Exam-2 of 2025 will be held from **28th January 2026 to 01st February 2026**. The **registration period** for the candidates eligible for appearing in these exams will be **from 22.12.2025 to 02.01.2026**. The Date-Sheet of the examination & Examination Centres have also been circulated in the said letter which is attached herewith for general information to all eligible candidates.

All the existing departmental candidates for SAS and both fresh as well as existing candidates for Incentive/CPD-I, II & III Exam -2 of 2025 are requested to email the duly filled in Pre-Registration Form through their official email to email ID ashimkumarm.serly@cag.gov.in and also to shiladityad.wbl.ae@cag.gov.in **latest by 26th December 2025**. Candidates will fill up the second part of the Registration Form by themselves on receipt of Login ID and password via sms after their candidatures are activated by the Examination Registration Officer (ERO). **The link for Registration is the same as in the previous Exam. 1 of 2025 i.e. <https://cagexam.in>**. The chance of a candidate would be counted once she/he registers and there is no scope for withdrawal

In respect of existing DA cadre candidates, the Pre-Registration Form may please be routed through Sr.AO/WM.

The officials who are on deputation to other offices are to submit their willingness/applications alongwith pre-registration form directly through email to ashimkumarm.serly@cag.gov.in and shiladityad.wbl.ae@cag.gov.in under intimation to Administration Section of the borrowing offices **on or within 26.12.2025**. Such candidates will make all examination related communication with their parent offices directly, for timely completion of registration process/other examination related issues.

The cut-off date for determining eligibility criteria in respect of SAS/I/CPD-I, II & III Exam-2 of 2025 is 01.09.2025.

The eligibility criteria for appearing in the CPD-I, II & III and Incentive Examinations are provided below:-

CPD Test:-

All Sr AO/ Sr DAO's are eligible to appear for CPD-I Test. AAO/ DAO-I shall be eligible to appear in the CPD-I Test after completion of four years' continuous service in the grade.

The CPD-II Test can be taken by Sr. AO/AAO/Sr.DAO/ DAO-I after completion of four years from qualifying CPD-I Test.

Sr AO/AAO/ Sr DAO/DAO-I are eligible to appear CPD-III Test after completion of 3 years from qualifying CPD-II Test.

Incentive Examination:-

All Sr. AO/ Sr. DAO's are eligible to appear for Incentive Examination. AAO/ DAO-I are eligible to appear for Incentive Examination after completion of 1 year continuous service in the grade.

Regarding number of permissible chances to pass the SAS Examination, candidates are requested to go through Headquarters Examination Wing Circular No. 11 of 2020 dated 19.10.2020 circulated vide this Office Order No. PAGAEWB/02/02/189/130 dated 27.10.2020.

It is also requested to take note of the circulars, revised syllabus and other materials being uploaded on the CAG's website from time to time.

In continuation of Exam Wing letter No. 529/26-Exam/SAS Etc./Exam/2025 dated 19.11.2025, the SAS/RA/I/CPD-I, II & III Exam-2 of 2025 will be held from 28th January 2026 to 01st February 2026. The Date Sheet of the Examination is as under:

The registration will be opened to the candidates who have been exempted/already qualified the Preliminary Examination and belong to offices where vacancies are available as well as existing departmental candidates & all DRAAOs for SAS Exam-II of 2025 & all candidates (fresh/existing) for RA/Incentive/CPD-I, II & III Exam-II of 2025. Registration period for the candidates eligible for appearing in these exams will be from 22.12.2025 to 02.01.2026. The cut-off date for eligibility for the examination is 1st September 2025.

3. All HoDs are required to nominate a Group Officer as Examination Registration Officer (ERO) to manage and supervise the registration process. The basic data i.e. Name, DoB, Category etc. as mentioned in Service Books of the new candidates will be entered into the first part of the Registration Form by the ERO. Thereafter, the fresh candidates will complete the second part (exam details) of the Registration Form by themselves. The existing candidates will fill up the second part of the Registration Form after activation by the ERO. The ERO will


verify and validate the data entered into the online registration forms to enable the HoD to approve their candidature. The onus of correctness of eligibility and data will be completely on the field offices. The registration process including ERO validation/HoD approval may be completed as soon as possible but latest by 09.01.2026. Chance of a candidate would be counted once she/he registers and there is no scope for withdrawal. The link for Registration and user id & password of ERO & HoD for registration/validation/approval will be the same as in the previous SAS/RA/I/CPD-I, II & III Exam-1 of 2025.

4. The officials who are on deputation to other offices within the department may submit their willingness/ application directly to their parent offices under intimation to Administration branch/section of the borrowing offices. Such candidates will make all examination related communication with their parent offices directly, for timely completion of registration process/other examination related issues.

5. The examination will be conducted in the 28 cities (copy enclosed). Candidates are permitted to appear only in their city of present posting or the city designated for that city by the Examination Wing. Candidates appearing for the examination at city other than their station of posting may be treated as on tour on official duty and shall be entitled to TA/DA as admissible.

6. All communications with exam wing will be made at email id saoexam@cag.gov.in. Further, for speedy/timely communication, Sr. AOs/AAOs who look after the examination matter in field offices may share their Mobile No./Email id with Sr.AO (Exam) .
