OFFICE ORDER

Subject: Online registration for SAS/I/CPD-I, II & III Examination - II of 2025.

With reference to Headquarters' Circular N. 03 of 2025 issued vide Letter No. 612/26- Exam/SAS etc Exam/2025, dated 19.12.2025(enclosed), the SAS/RA/I/CPD-I, II & III Exam-2 of 2025 will be held from 28th January 2026 to 01st February 2026. The cut-off date for eligibility for the examination is 1st September 2025. It is to intimate that the online registration for SAS/I/CPD-I, II & III Examination – II of 2025 will be commenced from 22.12.2025 and will end on 02.01.2026.

The eligibility criteria for appearing in SAS/I/CPD-I, II and II Examination-II of 2025 is as mentioned below:-

1. SAS Examination

- i) Only the candidates who belong to **ST category** and exempted/already qualified the Preliminary Examination as well as existing departmental candidates are allowed to appear in SAS Examination - II of 2025.
- ii) Divisional Accountants or Divisional Accounts Officers-II, who have successfully completed their probation period on or before 1st September 2025 and **belong to the ST category only**.

2. Incentive Examination:-

- i). Sr. Accounts Officers (Sr. AO)/Sr. Divisional Accounts Officers (Sr. DAO) are eligible to appear in the Incentive Examination.
- ii). Assistant Accounts Officers/Divisional Accounts Officers Gr. I who have completed one-year continuous service in the grade/cadre as on 1st September'2025.

3. CPD I / II & III Examination:-

- i). All Sr. AO/Sr. DAOs are eligible to appear in CPD-I Examination. All AAOs/DAOs-Gr I who have completed four years of continuous service in the grade/cadre as on 1st September'2025 are also eligible to appear in CPD-I Examination.
- ii). All Sr AO/Sr. DAO/AAOs/DAOs Gr I who have successfully completed four years of regular service as on 1st September'2025 after qualifying the CPD-I Examination are eligible to appear in CPD-II Examination.
- iii). All candidates after completion of three years as on 1st September'2025 after qualifying the CPD-II Examination are eligible to appear in CPD-III Examination.

In view of the above, candidates (fresh/existing) who intend to appear in

SAS/I/CPD-I, II & III Examination – II of 2025 can submit their details (in enclosed format) latest by **31st December 2025** in Training & Exam Section. The duly filled application may be sent through email on agaebihar@cag.gov.in to enable Part-II registration for the said examination.

Officers/Officials who do not submit their application before the due date would not be allowed to register for the examination later. Applications should be complete in all respects. Incomplete applications are liable to be rejected.
