OFFICE ORDER

The grant of NFU will be subject to the following terms and conditions:


1. Option for fixation of pay under FR-22 (I) (a) (1) may be exercised within one month to have the pay fixed on the date of grant of NFU or from the date of next increment.
2. NFU will be reckoned for financial upgradation under Modified Assured Career Progression Scheme (MACPS). Subsequent financial upgradation under MACPS, if any, is to be reckoned from the date of grant of NFU.
3. Due to re-fixation of pay subsequent to grant of NFU, arrears of pay and allowances will be paid to the official as admissible under 7th CPC.
4. The benefits of financial upgradation under NFU, extended vide this office order, may be reviewed on subsequent clarification/order/instruction received from Headquarters.
