Dear Sir/Madam,

With reference to the subject cited above, I would like to inform you that the University intends to fill up one vacant post of internal Audit Officer (IAO) in the pay band-3 (Rs. 15,600 - 39,100) with grade pay of ₹7600/- revised level 12 as per 7th CPC pay matrix Rs. 78,800 - 209,200 on deputation basis initially for three years to be extended further in accordance with the instruction of DoPT, GoI. In addition to pay and allowance the selected officer will be entitled to Deputation (Duty) Allowance as per Central Government Rules and University accommodation subject to availability and as per quarter allotment rules.

As per the University rules the post of Internal Audit Officer is to be filled from amongst the Officers of any of the organized Audit & Account Cadre/Service in the pay band of Rs. 15,600 - 39,100/- with grade pay of ₹7600/- revised Level 12 as per 7th CPC pay matrix or in the same pay band having minimum 3 years experience in the Level 11 or in the same pay band in Level 10 having minimum 5 years experience. The job involves in depth application of University and GoI Rules/instructions related to financial accounting, establishment and public work matters.

It is requested that a panel of at least three eligible and suitable officers along with their detail of service and experience and Annual Confidential Report/APAR for preceding five years may please be sent to the undersigned at the earliest for necessary action. The University may call the empanelled officers for interview, if considered necessary.
