Subject : Grant of Dearness Relief to the Jammu & Kashmir Government pensioners/family pensioners with effect from 01-07-2025.

In continuation to this office circular No. Pen. Co-ordn./Jammu & Kashmir/Vol.- III/DR/67 dated 03-09-2025, this is to state that Government of Jammu & Kashmir in their Order No. 273-F of 2025 dated 28-10-2025 has sanctioned dearness relief to JK UT pensioners/family pensioners as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-07-2025	58% of basic pension/family pension

2. The payment on account of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. The other provisions governing grant of dearness relief on pension/family pension such as regulation of Dearness Allowance during employment/re-employment, where more than one pension is drawn etc. and other provisions of the existing orders/rules (as are not in conflict of the provisions of this order) shall continue to remain in force.

4. Having been authorised by the Principal Accountant General (A&E) Jammu & Kashmir in their authority No. Pen.A/cs/2025-26/DA/789-822 dated 24-11-2025, it is requested to make necessary arrangement for payment of dearness relief @ 58% on basic pension/family pension with effect from 01-07-2025 to all eligible Jammu & Kashmir UT pensioners/family pensioners keeping in view the instructions laid down above and after making proper adjustment.
