CIRCULAR

Subject :- Merger of IE papers, IE-3 & IE-4 into revised IE-3 (IT-Theory & Practical) and Date sheet revision of SAS/RA/I/CPD Exam-2 of 2025.

Headquarters office Examination Wing Circular No. 1 of 2026 & Circular No. 2 of 2026 dated 21.01.2026 circulated vide letter No. 100 Exam/MCQ/SAS/2025-37 and No. 101-26/Exam/SAS etc/Exam 2025 respectively have intimated the Merger of IE papers, IE-3 & IE-4 into revised IE-3 (IT-Theory & Practical) and Date sheet revision of SAS/RA/I/CPD Exam-2 of 2025.

As per circular No. 1 of 2026, it is stated that competent authority has decided to merge the existing IE-3 and IE-4 papers into a single paper to be title as IE-3 (IT-Theory & Practical) in alignment with the revised PC-3 syllabus. The revised syllabus of PC-3 is available on CAG's website. Exemption in the revised IE-3 shall be admissible only to those candidates who have already passed both IE-3 & IE-4 papers under the old/existing format. Further, as per para 9.9.10 of the CAG's MSO (Admn) Vol. I, AAOs/Sr.AOs who have passed the erstwhile SOG/SAS Exam with 'Computer Systems' paper shall not be required to appear in the revised IE-3 paper.

Further, as per circular No. 2 of 2026, Hqtrs office has stated that due to technical and administrative reasons, the shifts of papers scheduled to be held on 29.01.2026 have been revised (copy attached).

Sub: Merger of Incentive Examination (IE) Papers, IE-3 and IE-4 into revised IE-3
(Information Technology – Theory & Practical).

The syllabus of SAS Exam has been revised and is to be implemented w.e.f. Exam-2 of 2025. PC-3, IT (Theory) and PC-4, IT (Practical) papers of existing SAS syllabus, have been merged in a single paper PC-3, IT (Theory and Practical)- (PC-3) in the revised SAS syllabus. In this regard, it is stated that competent authority has decided to merge the existing Incentive Examination IE-3 [IT (Theory)] and IE-4 [IT (Practical)] papers into a single paper to be titled as Incentive Examination IE-3 – Information Technology (Theory & Practical) in alignment with the revised PC-3 syllabus. The revised syllabus of PC-3 is available on CAG's website.

2. Exemption in the revised IE-3 (Information Technology – Theory & Practical) shall be admissible only to those candidates who have already passed both IE-3 and IE-4 papers under the old/existing format.
3. Further, as per para 9.9.10 of the CAG's MSO (Administration) Vol. I, AAOs/Sr. AOs who have passed the erstwhile SOG/SAS Examination with "Computer Systems" paper shall not be required to appear in the revised IE-3 (Information Technology – Theory & Practical) paper.
