Subject : Grant of dearness relief to the Goa Government Freedom Fighter pensioners/family pensioners with effect from 01-07-2025.

In continuation to this office circular No. Pen. Co-ordn./Goa/Vol.-VI/DR-FF/66 dated 03-09-2025, this is to state that the Government of Goa in their Department of Home (General) Order No. 11/4/2012-HD(G)/Part I/138 dated 13-01-2026 has adopted the rate of dearness relief announced by the Central Government in respect of their Freedom Fighter pensioners/family pensioners, raising it from 55% to 58% with effect from 01-07-2025.

2. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Director of Accounts, Government of Goa in their letter No. DA/PA-I/Pens/25-26/TR-1039/DR-1731 dated 23-01-2026, it is requested to make necessary arrangement for payment of dearness relief on pension/family pension to the Goa Government Freedom Fighter pensioners/family pensioners @ 58% with effect from 01-07-2025 after proper adjustment.

4. The charges on this account are debitable to the head "8793-I.S.S. A/cs.; Government of Goa etc."
