Subject: Reallocation of work between O/o the Pr. Accountant General (Audit-I) Maharashtra, Mumbai and O/o the Accountant General (Audit-II) Maharashtra, Nagpur.

In partial modification of SMU notification No.59-A/43-SMU/2017 dated 9 March 2020, No. 120/09-SMU/2020 dated 20 May 2020, No.176/09-SMU/2020 dated 4 August 2020, No. 307/17-SMU/2022 dated 22 August 2022 and No.20/17-SMU/2022 dated 11 January 2024, the following decisions are taken regarding re-allocation of work between the O/o the Pr. Accountant General (Audit-I) Maharashtra, Mumbai and O/o the Accountant General (Audit-II) Maharashtra, Nagpur:

- The Branch Office of O/o the Pr. Accountant General (Audit-I) Maharashtra, Mumbai, at Nagpur, is merged with O/o the Accountant General (Audit-II) Maharashtra, Nagpur.
- The Branch Office of O/o the Accountant General (Audit-II) Maharashtra, Nagpur, located at Mumbai, is merged with O/o the Pr. Accountant General (Audit-I) Maharashtra, Mumbai.
- The distribution of clusters between two offices would be as under:

- d) The final allocation of clusters within AMGs in both the audit offices would be done with approval of ADAI (WR).
- e) The final allocation of staff in two offices would be achieved in consultation with Staff Wing and Commercial Audit Wing at Hqrs.
- f) PD (P) wing will issue necessary orders regarding posting of Group Officers.

This notification shall come into force with immediate effect.
