ORDER

Whereas, it has been requested by the Assistant Engineer, Benmore Sub-Division- II, HPPWD Shimla-2 vide letter No. PW-SSD-II-Utility Duct/ 2026 30-31 dated 16.04.2026 to close the road from AG Chowk to Vidhan Sabha for the execution of work of underground Utility Duct from Oak Over to Marina Chowk.


And whereas, the Sr. Superintendent of Police, Shimla vide letter No. R/DSP(T)/26- 31529 dated 11.05.2026 has also recommended the permission to close the road from AG Chowk to Vidhan Sabha on certain conditions.

And whereas, keeping in view the urgency of the work and the recommendation of Sr. Superintendent of Police, Shimla, it is necessary to issue the order to restrict the movement of vehicles on the above road for above said work.

Now therefore, I, Anupam Kashyap, IAS, District Magistrate, Shimla in exercise the powers vested in me under section 115 & 117 of Motor vehicles Act, 1988 and all other powers enabling me in this behalf hereby order to close the road leading from **AG Chowk to Vidhan Sabha** w.e.f. 19.05.2026 to 18.06.2026 subject to the following conditions:

1. During the execution of the construction work, all kinds of traffic may be diverted from AG Chowk towards Cart Road, to ensure smooth traffic flow and avoid congestion in the affected area.
2. During the work of underground utility duct work site shall be properly covered by barricades, green net etc.
3. Adequate safety measures shall be taken to ensure the safety of pedestrians.
4. Proper arrangement of light shall be ensured during the night hours to avoid any untoward incident
5. Sign board depicting "Road closed" shall be erected on both sides of Road i.e. AG Chowk and Kennedy Chowk.
6. The work shall be completed within stipulated period of time.

The executing agency shall ensure all safety/security precaution to be followed for the pedestrian specially for the school children/ Senior Citizens.
