of Tripura Government Judicial Services with effect from  
01-01-2025, 01-07-2025 and 01-01-2026.*

In continuation to this office circular No. Pen. Co-ordn./Tripura/Vol.- VII/DR-Judi/19 dated 08-05-2025, this is to state that the Government of Tripura in their Memo No. F.5(6)-FIN(G)/79(Part-III)/103 dated 15-05-2025, F.5(6)-FIN(G)/79(Part-III)/649 dated 29-10-2025 and F.5(6)-FIN(G)/79(Part-III)/10 dated 04-05-2026 has enhanced the dearness relief from the existing rate of 53% to 55%, 55% to 58% and 58% to 60% with effect from 01-01-2025, 01-07-2025 and 01-01-2026 respectively to the pensioners/family pensioners of their Judicial Services.

Having been authorised by the Accountant General (A&E), Tripura in their authority No. Pen-1/Tripura Relief/Judicial/2025-26/2026-27/24568 dated 21-05-2026, it is requested to make necessary arrangement for payment of dearness relief @ 55%, 58% and 60% to all eligible pensioners/family pensioners of Tripura Government Judicial Services with effect from 01-01-2025, 01-07-2025 and 01-01-2026 respectively after proper adjustment.
