***Sub : RA 2026 Examination-I & II – Calling for applications for Pre-Examination Training***

The Pre-Examination Training for the candidates appearing for the 2026 Revenue Audit Examination-I & Examination II will be conducted during June 2026. The cutoff date for determining the eligibility is 1<sup>st</sup> March for Examination-1 and 1<sup>st</sup> September for Examination-2. The eligibility criteria in respect of Sr.AOs/AAOs for appearing in Revenue Audit examination are:

- i. Sr.AOs, after having one year of continuous service in the Revenue Audit Branch as AAO/Sr.AO or after having prescribed training in Revenue Audit.
- ii. Departmental officials who are promoted as AAO are eligible to appear in Revenue Audit Examination after completion of one year of continuous service in Revenue Audit Branch or have the prescribed training in Revenue Audit after completion of one year of continuous service as AAO.
- iii. Confirmed directly recruited AAOs are eligible to appear in Revenue Audit Examination after completion of one year of regular service in Revenue Audit Branch as a regular AAO or have the prescribed training in Revenue Audit after completion of one year of regular service after confirmation as AAO.

Sr.AOs/AAOs who have to undergo the prescribed training to appear for the 2026 RA Examination-1 & Examination-2 may submit their application in the prescribed form by e mail ([admin.ker1.au@cag.gov.in](mailto:admin.ker1.au@cag.gov.in)) **on or before 29.05.2026.**
