OFFICE ORDER

Subject: Application for pre-registration for SAS/I/CPD-I, II & III Examination-1 of 2026 -reg.

As per Headquarters' office letter No. 429/08-Exam/SAS etc. Exam/2026 dt. - 25/05/2026 read with 478/08- Exam/SAS etc. Exam/2026/Vol.-I dt. - 01/06/2026, the SAS/I/CPD-I, II & III Examination-1 of 2026 will be held from 22nd June to 27th June 2026 (copy enclosed). The **cut-off** date for eligibility for the examination is **1st March 2026**. Applications are therefore invited for pre-registration of candidature for SAS/I/CPD-I, II & III Examination-1 of 2026 from Officers/Officials fulfilling the eligibility criteria as mentioned below :-

1. SAS Examination: -

- i. All existing candidates are allowed to appear in SAS Exam-1 of 2026.
- ii. Divisional Accountants or Divisional Accounts Officers-II, who have successfully completed their probation period on or before 1st March 2026 and **belong to the ST category only.**

2. Incentive Examination: -

- i). All Sr. Accounts Officers (Sr. AOs)/Sr. Divisional Accounts Officers (Sr. DAOs) are eligible to appear in the Incentive Examination.
- ii). Assistant Accounts Officers/Divisional Accounts Officers Gr. I who have completed one-year continuous service in the grade/cadre as on 1st March'2026.

3. CPD I/ II & III Examination:-

- i). All Sr. AOs/Sr. DAOs are eligible to appear in CPD-I Examination. All AAOs/DAOs Gr-I who have completed four years of continuous service in the grade/cadre as on 1st March'2026 are also eligible to appear in CPD-I Examination.
- ii). All Sr AOs/Sr. DAOs/AAOs/DAOs Gr-I after completion of four years as on 1st March'2026 from qualifying their CPD-I test are eligible to appear in CPD-II Examination.
- iii). All candidates after completion of three years as on 1st March'2026 from qualifying their CPD-II test are eligible to appear in CPD-III Examination.

In view of the above, a single pre-registration form may be submitted by the Officers/Officials clearly indicating the Exam(s) in which they intend to appear. Officers/Officials are required to submit duly completed Pre-registration form in the enclosed format to Trg & Exam section or through email at agaebihar@cag.gov.in by **08.06.2026**. After due date, application would not be allowed for the registration. (Candidates are also advised to visit Headquarters' office website regularly for updates.)

Note:-All fields of the application are mandatory. Application should be completed in all respects. Incomplete applications will be summarily rejected.



In continuation of Exam Wing letter No. 429/08-Exam/SAS etc. Exam/2026 dated 25.05.2026, the SAS/RA/I/CPD-I, II, &III Examination -1 of 2026 will be held from 22nd June 2026 to 27th June 2026. The Date Sheet of the Exam is as under:

2. Registration will be opened where vacancies are available in the respective cadres. Fresh candidates may be allowed to appear after giving an undertaking that they would only opt for CEA or CRA after passing the exam. The cut-off date for eligibility for the examination is 1st March 2026.


3. All HoDs are required to nominate a Group Officer as Examination Registration Officer (ERO) to manage and supervise the registration process. The basic data i.e. Name, DoB, Category etc. as mentioned in Service Books of the new candidates will be entered into the first part of the Registration Form by the ERO. Thereafter, the fresh candidates will complete the second part (exam details) of the Registration Form by themselves. The existing candidates will fill up the second part of the Registration Form after activation by the ERO. The ERO will verify and validate the data entered into the online registration forms to enable the HoD to approve their candidature. The onus of correctness of eligibility and data will be completely on the field offices. Chance of a candidate would be counted once she/he registers and there is no scope for withdrawal. The link for registration and user id & password of ERO & HoD for registration/validation/approval will be the same which was used in the previous SAS/RA/I/CPD-I,II&III-2 of 2025.

4. The officials who are on deputation to other offices within the department may submit their willingness/ application directly to their parent offices under intimation to Administration branch/section of the borrowing offices. Such candidates will make all examination related communication with their parent offices directly, for timely completion of registration process/other examination related issues.

5. The examination will be conducted in 28 test-centre cities. Candidates are permitted to appear only in their city of present posting or the city designated by the Exam Wing. Candidates appearing for the examination at city other than their station of posting may be treated as on tour on official duty and shall be entitled to TA/DA as admissible.

6. All communications with Exam Wing will be made at email id saoexam@cag.gov.in. Further, for speedy/timely communication, Sr. AOs/AOs responsible for examination matters in field offices may share their Mobile No./Email id with Sr. AO (Exam).
