*Subject : Grant of Dearness Relief to the Tripura Government pensioners/
family pensioners with effect from 01-04-2026*

In continuation to this office circular No. Pen. Co-ordn./Tripura/Vol.- VII/DR/124 dated 24-12-2025, this is to state that the Government of Tripura in their Memo No. F.5(1)-FIN(PC)/2021/2845-3044 dated 16-03-2026 has sanctioned dearness relief on the revised pension/family pension of their pensioners/family pensioners, as under :

Date of effect	Rate of dearness relief per month
01-04-2026	41% of revised basic pension/family pension

2. Payment of dearness relief involving fraction of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
3. Having been authorized by the Accountant General (A&E), Tripura in their authority No. Pen-1/Tripura Relief/2026-27/24685 dated 26-05-2026, it is requested to make necessary arrangement for payment of dearness relief to all eligible Tripura Government pensioners/family pensioners @ 41% on their revised basic pension/family pension with effect from 01-04-2026 after proper adjustment.
4. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Tripura etc."
