Subject : Grant of Medical Allowance to the Rajasthan Government pensioners/family pensioners with effect from 01-04-2012.

This is to state that the Rajasthan Government pensioners/family pensioners are entitled to get Fixed Medical Allowance @ Rs.300/- (Rupees three hundred) only per month with effect from 13-10-2014 on the basis of Government of Rajasthan Order No. F.1(2)FD/Rules/2014 dated 13-10-2014, circulated under this office No. Pen. Co-ordn./Rajasthan/Vol.-VI/MA/38 dated 19-06-2015.

2. Government of Rajasthan in their Order No. F.1(6)FD/Rules/2012 dated 24-04-2012 has sanctioned Fixed Medical Allowance @ Rs.300/- (Rupees three hundred) only per month with effect from 01-04-2012.

3. Fixed Medical Allowance shall be payable to the pensioner/family pensioner provided that the pensioner/family pensioner is not availing the medical facility under the Rajasthan State Pensioners' Medical Concession Scheme, 2009.

4. Having been authorized by the Principal Accountant General (A&E), Rajasthan in their authority No. PA/Order/K-107/I/1354082/2026 dated Nil, it is requested to make necessary arrangement for payment of Fixed Medical Allowance @ Rs.300/- (Rupees three hundred) only per month along with arrear to the Rajasthan Government pensioners/family pensioners with effect from 01-04-2012 keeping in view the instructions laid down above after proper adjustment.
