Sub: Clarification regarding admissibility of additional six chances in SAS Examination consequent upon implementation of revised syllabus from SAS Examination-2 of 2025.


Madam/Sir,

In continuation of Circular No. 11 of 2020 dated 19.10.2020 regarding admissible chances in the SAS Examination, it has been decided that as per the said Circular, the additional six chances are admissible only to those candidates who had qualified five papers out of nine papers within the first six (normal) attempts.

It is clarified that candidates who had fulfilled the eligibility condition prescribed under Circular No. 11 of 2020 for grant of the additional six chances prior to implementation of the revised syllabus from SAS Examination-2 of 2025 shall be permitted to avail the said additional six chances.

It is further clarified that the requirement of qualifying five papers within the first six (normal) attempts for becoming eligible to avail the additional six chances, as prescribed under Circular No. 11 of 2020, remains unchanged under the existing syllabus.
