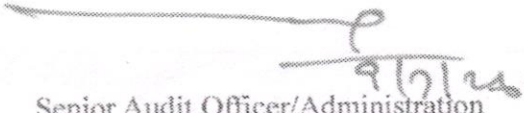
2. Interested officials possessing requisite experience and qualifications may forward their applications, duly filled in, through their respective Cadre Controlling Authority, along with the following documents:

- (i) Biodata
- (ii) Summary of APAR (Annual Performance Assessment Report) for the last three years i.e., 2022-23, 2023-24, and 2024-25/2025-26 (Annexure-II), along with copies of the APAR duly attested on each page; and
- iii) Vigilance Clearance Certificate certifying that no departmental, judicial, or vigilance case is either pending or contemplated against the applicant, and that their integrity is beyond doubt.

3. The required documents of eligible candidates must be scanned and sent to this office by email at: coefahyd@cag.gov.in. To avoid potential delays associated with postal delivery, documents may be forwarded through electronic mail (email) by the respective Cadre Controlling Authorities.

4. The candidate will be selected by a committee constituted by the Competent Authority.
5. The initial period of deputation shall be three years, which may be extended on the basis of continued suitability and administrative convenience. However, if the performance or conduct of any deputed employee is found to be unsatisfactory or due to other administrative contingencies, CoEFA, Hyderabad reserves the right to repatriate the individual to his/her parent office at any point in time.
6. In accordance with the revised deputation guidelines issued by the C&AG of India vide Letter No. 60-Staff(App)-I/14-2023, dated 27-01-2025, a mandatory "cooling off" period of three years must be observed between two successive deputations, including any deputations outside the department. Therefore, strict compliance with this condition must be ensured before forwarding any nominations for deputation to CoEFA, Hyderabad.
7. Selected official shall have no absolute right or claim to permanent absorption in the post.
8. Attention is drawn towards the Headquarters Office Circular No. 269/Trg. Div/42-A/2019 dated 18.09.2019, through which comprehensive guidelines were issued to regional offices to increase the availability of administrative and faculty staff in training institutions/centres. The aforementioned guidelines are reiterated as follows:

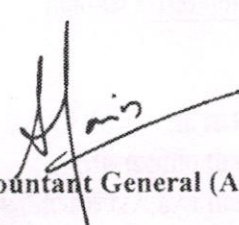
