ORDER

In terms of para 7 of guidelines issued by the Headquarters' Office regarding Transfer and Posting of Divisional Accountants dated 22.01.2025, the Supervisory Charges of the following Divisional Accountants (Probationer) have been entrusted to the officials mentioned in 'Annexure-I' with immediate effect.

In this regard, following instructions are issued for the officials holding Supervisory charge and the DAs (Probationer):

1. The officials holding supervisory charge will be the signatory authority of accounts of the division. The Supervising official will be held responsible for the lapse, if any.
2. DAs (P) are not authorized to sign the accounts of the division until they pass the Divisional Accountant Grade Examination and complete their probation successfully.
3. The DA (P) will be held responsible for preparation of accounts of the division and the same will be examined and signed by the supervising officer and the Executive Engineer of the division. The accounts and other relevant documents of the respective division are to be forwarded to the office of the Pr. Accountant General (A&E), West Bengal by due date and the same may be ensured by the DA (P) as well as by the supervising officer.
4. Adverse comments by supervising officer/the Executive Engineer of the division on performance of the DA (P) may impact on his/her completion of probation period and transfer/posting of the concerned DA (P).
