Shri **Rajkishore Mohapatra**, Sr. Audit Officer, has been entrusted with the charge of the vacant post of Dy. Accountant General/ AMG-II in this office in terms of Headquarters circular letter No. 1204-G.E-I/Adhoc.App./27-2026 dated 23.07.2026 with effect from 14.08.2026 (AN) purely as an adhoc arrangement subject to the following conditions;

- (1) The entrustment of the charge would be initially for a period of six months or till a regular Group Officer is posted against the said vacant post, whichever is earlier.
- (2) This arrangement does not constitute promotion or appointment to IA&AS or to any post of higher scale of pay.
- (3) While looking after the charge of the said post, Shri **Rajkishore Mohapatra** will be paid an additional remuneration of Rs. 6000/- (Rupees Six thousand only) in addition to his pay in his own Pay Level 11 provided the period is for 31 days or above but not exceeding, in any case, beyond 6 months.
- (4) Will not exercise the statutory powers vested in the said post under C.C.S (C.C.A) rules, 1965.
- (5) Will not be entitled to any other Special pay/allowance in addition to the additional remuneration of Rs. 6000/- (Rupees Six thousand only) pm mentioned above.
- (6) This ad-hoc arrangement can be terminated at any time without assigning any reason.
