*Subject : Grant of dearness relief to the Mizoram
Government pensioners/family pensioners with
effect from 01-04-2026.*

In continuation to this office circular No. Pen. Co-ordn./Mizoram/Vol.- IV/DR/153 dated 17-03-2026, this is to state that Government of Mizoram in their FD Memo No. G.17011/6/2019-F.APF dated 27-11-2025 have sanctioned revised rates of dearness relief to their pensioners/family pensioners as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-04-2026	46% of basic pension/family pension

2. Payment of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

3. Having been authorised by the Director, Local Fund Audit & Pension, O/o the Director, Local Fund Audit & Pension, Accounts & Treasuries, Government of Mizoram in their authority Nos. G.19020/108/2001-CCA(P)/300 dated 06-02-2026 and G.19020/108/01-CCA(P)/342 dated 17-06-2026, it is requested to make necessary arrangement for payment of dearness relief @ 46% on the basic pension/family pension of all eligible Mizoram Government pensioners/family pensioners with effect from 01-04-2026 after proper adjustment.
