*Subject : Grant of dearness relief to the Uttarakhand
Government pensioners/family
pensioners with effect from 01-01-
2026.*

In continuation to this office circular No. Pen. Co-ordn./Uttarakhand/Vol.-II/DR/122 dated 24-12-2025, this is to state that the Government of Uttarakhand in their FS O.M. No. 396999/XXVII(10)/E-22807/2022 dated 18-05-2026 has decided to sanction dearness relief for their pensioners/family pensioners whose pension/family pension has been revised as per recommendation of the 7th Pay Commission at the rate and from the date as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-01-2026	60% of basic pension/family pension

2. Payment of dearness relief involving a fraction of a rupee shall be rounded off to next higher rupee.

3. These orders will also be applicable to such teaching and non-teaching pensioners of Institutions aided from the State of Uttarakhand under the Education/Technical Education Department whose pension/family pension is at par with the pensioners of the Government of Uttarakhand.

4. These orders will not be applicable to the Judges of High Court of Uttarakhand, Chairman and Members of Uttarakhand Public Service Commission, Civil/Family Pensioners of local bodies and Public Undertaking Corporation etc. In respect of such categories separate orders will be issued by the respective departments.

Having been authorised by the Accountant General (A&E), Uttarakhand in their authority No. P.A./Pension/Uttarakhand Order/D.R.-48/2026-27/I/1528330/2026 dated 17-07-2026, forwarded with letter No. P.A./Pension/Uttarakhand Order/Dearness Relief/D.R.-48/2026-27/503 dated 20-07-2026, it is requested to make necessary arrangement for payment of dearness relief to all eligible Uttarakhand Government pensioners/family pensioners @ 60% on their basic pension/family pension with effect from 01-01-2026 after proper adjustment.

7. The charges on this account are debitable to the head "8793-I.S.S.A/cs.; Government of Uttarakhand etc."
