OFFICE ORDER

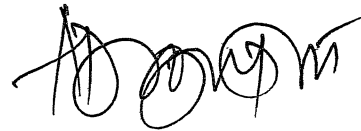
Consequent upon the approval of the President of India as conveyed by the Headquarters' letter bearing No. 139/Staff (Appt-V)/Sr. AO/Promotion/42-2026 dated 29.06.2026, the Principal Accountant General (A&E), West Bengal has been pleased to order the promotion of Shri Shantanu Kr. Dutta, Divisional Accounts Officer, Grade-I to the post of Senior Divisional Accounts Officer (Group 'A') in pay scale (Rs. 56,100-Rs.1,77,500) of Level 10 of the Pay Matrix under CCS (Revised Pay) Rules, 2016 for the Panel Year 2026 with effect from 01.09.2026 (F/N) or the date of his taking over the charge to the post of Sr. Divisional Accounts Officer, whichever is later.

The promotion is being offered to the above Divisional Accounts Officer, Grade-I against the availability of actual and clear vacancies in the post of Sr. Divisional Accounts Officer (Group-A). Such promotion is in the interest of the public service. He may submit the charge assumption report as Sr. DAO through his respective Divisional Officer/Executive Engineer along with a declaration that no prosecution of criminal case(s) is/are pending as on date in any court of law, special police establishment or police station against him and he will be liable for reversion and disciplinary proceedings, if the information furnished by him is found to be false or any material suppression of factual information comes to notice later.

Subject to eligibility, his pay in Level-10 of the 7th CPC Pay Matrix will be fixed under Rule 13 of CCS (Revised Pay) Rules, 2016 notified vide Gazette Notification GSR 721 (E) F. No. 1-2/2016-IC dated 25.07.2016. He may exercise the option for fixation of pay on promotion within one month from the date of promotion.

As per Recruitment rule for the post of Sr. DAO in Part-II, Section 3, Sub-Section (1) of Gazette of India vide GSR No. 10 dated 17.01.2020 published in Gazette of India on 25.01.2020, on his promotion, Sr. DAO will be on probation for a period of 2 (two) years followed by confirmation.

It is issued subject to further orders which may be passed by the Hon'ble Supreme Court as stipulated in para 5 of DOPT OM No. 36012/11/2016-Estt. (Res-I) (Pt-II) date 15.06.2018. Moreover, the promotion shall be subject to the judgement dated 28.01.2022 of the Hon'ble Supreme Court of India in Jarnail Singh & Ors in Civil Appeal No. 629/2022 arising out of SLP No. 30621/2011 and further orders that may be passed by the Hon'ble Supreme Court of India as mentioned in DoPT's OM No. 36012/16/2019-Estt (Res.) dated 12.04.2022.

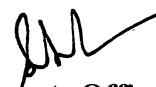
