In terms of instructions issued vide Headquarters office letter No. 131 NGE(JCM)/20-2010 . KW-II dated 21.02.2012, no permission can be granted to any individual or association to hold demonstration within office premises.

As per Rule 7 of CCS (Conduct) Rules, 1964 and GoI Decision (2), thereunder no Government servant shall engage himself or participate in demonstration/ meetings and or resort to or in any way abet any form of strike. Such action on the part of Government servants will be viewed seriously and action under the provisions FR 17 and FR 17 A for unauthorized absence may be taken. Such employees also render themselves liable for a departmental action under the Central Civil Services (CCA) Rules, 1965.
