Subject : Grant of dearness relief with effect from 01-07-2024, 01-01-2025 and 01-07-2025 to the Tamil Nadu Government pensioners/family pensioners on their un-revised pension/family pension.

In continuation to para 2 of this office circular No. Pen. Co-ordn./Tamil Nadu/Vol.-VIII/DR-un-rev/150 dated 10-01-2025, this is to state that the Government of Tamil Nadu in their G.O.(Ms.) Nos. 351 dated 19-11-2024, 98 dated 28-04-2025 and 250 dated 13-11-2025 has sanctioned dearness relief to their pre-2016 pensioners/family pensioners, whose pension/family pension have not been revised as per Tamil Nadu Government G.O.(Ms.) No. 313 dated 25-10-2017, circulated under Pen. Co-ordn./Tamil Nadu/Vol.VII/Revision/208 dated 21-03-2018, as under :

01-07-2024	246% of basic pension/family pension
01-01-2025	252% of basic pension/family pension
01-07-2025	257% of basic pension/family pension

3. The amount of dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee if such fraction is 50 paise and above and shall be ignored if it is less than 50 paise.

4. Having been authorized by the Principal Accountant General (A&E), Tamil Nadu in their authority Nos. PAG (A&E)/Entt-29/1/Mail/2025-26/195/2/2/13970 dated 11-08-2025 and AG (A&E)TN/Pen29/U-I/2025-26/29301 dated 04-12-2025, it is requested to make necessary arrangement for payment of dearness relief to the Tamil Nadu Government pensioners/family pensioners on their un-revised pension/family pension at the rates and from the dates mentioned above after proper adjustment.

5. The charges on this accounts are debitable to the head "8793-I.S.S. A/cs.; Government of Tamil Nadu etc."
