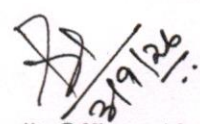

RCB & KC, Bengaluru is seeking applications on deputation for one post of Sr Audit Officer: Administration and one post of Assistant Audit Officer/Information Systems (IS) (State cadre/CEA/CRA/Commercial/Railways/A&E/any other cadre). The other details regarding the deputation posts are as under:

1. Applications of officers/officials who are willing to be considered for deputation in RCB & KC, Bengaluru for the above-mentioned posts may forward the application to RCB & KC, Bengaluru through proper channel on or before **15.09.2026** along with their biodata in the format prescribed in **Annexure I** and certified copies of APAR for the last five years duly attested on each page by the competent authority. A certificate to state that no disciplinary/court/vigilance case is either pending or contemplated against the applicant should also be forwarded along with the application.
2. The terms and conditions of the deputation post would be governed by the extant instructions governing deputation in Indian Audit and Accounts Service.
3. The post of Sr AO Administration has been called for against a Regular Temporary (RT) Post which has been extended by Staff Wing upto 28.02.2027. Further extension of this post would be as per the directions of Staff Wing issued from time to time.
4. The successful candidates would be decided by the selection committee and would be approved by the competent authority. Necessary practical test/personal interview may also be conducted as per the orders of the competent authority.
5. The term of deputation for the posts will be initially for a period of one years and extendable upto three years. RCB & KC, however, reserves the right to repatriate an officer/official on deputation at any time even before the stipulated period.
6. Officers on deputation will be entitled for deputation allowance/training allowance as applicable in accordance with the relevant instructions of DoPT/Headquarters Office as issued from time to time.
7. Maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of application for the post. However, in exceptional circumstances and in deserving cases, proposals for relaxation of the upper age limit may be considered by RCB&KC, Bengaluru for being taken up with Headquarters Office for approval.
8. **Wide publicity may be given to this circular and attention in invited to Headquarters Circular no: 269/Trg/Div/42-A/2019 dated 18-09-2019 which inter-alia stipulates that the field offices should display/circulate deputation notifications issued by RTIs/RTCs among staff and forward such applications received to RTIs/RTCs.**

- 9 In General, all the extant rules applicable for deputation to any post in IA&AD are to be taken to have been included in this notification.
