सरकारी आवास आवंटन (आईए एवं एडी) नियम, 2021 के पैरा 7(5) के अनुसार

- यदि कोई आबंटी उक्त आवास के आबंटन की तारीख से आठ दिनों के भीतर आवासीय आवास के आबंटन को स्वीकार करने में विफल रहता है, या स्वीकृति पत्र प्राप्त होने की तारीख से पांच कार्य दिवसों के भीतर उस आवास का अधिगृहण करने में विफल रहता है, उसे आबंटन की अस्वीकृति की तारीख से तीन महीने की अवधि के लिए आवास के लिए आवेदन करने से वंचित कर दिया जाएगा बशर्ते कि उस प्रकार के आवास के लिए एक महीने के लाइसेंस शुल्क का भुगतान किया जाए।
- आबंटन की अस्वीकृति की तारीख की गणना आबंटन की तारीख से की जाएगी।
- निम्न श्रेणी प्रकार के आवास में रहने वाला आबंटी यदि उस प्रकार के आवास के प्रस्ताव को स्वीकार करने से इंकार करता है जिसके लिए वह इन नियमों के तहत पात्र है, तो उसे पूर्व में आबंटित आवास में रहने की अनुमति दी जाएगी। उल्लिखित है कि ऐसा करने वाला आबंटी ऐसे आबंटन की अस्वीकृति की तारीख से छह महीने की अवधि के लिए दूसरे आबंटन के लिए पात्र नहीं होगा।
- आबंटिती को बल्क-सप्लाय स्कीम के अंतर्गत क्वार्टर के लिए नवीन विद्युत कनेक्शन हेतु लागू नियमानुसार सुरक्षा राशि जमा करानी होगी। वितरण कंपनी द्वारा टैरिफ संशोधन के आधार पर समय समय पर संशोद्धि ऊर्जा शुल्क बकाया सहित, बल्क-सप्लाय स्कीम के तहत कवर किए गए क्वार्टर के आबंटन के लिए कर्मचारी के वेतन और भत्तों में से काट लिया जाएगा। लागू दरों पर जल शुल्क एवं कोई अन्य बकाया भी उससे (कर्मचारी) वसूल किया जाएगा।

As per para- 7(5) of Allotment of Govt. Residences (IA&AD) Rules, 2021

- If any allottee fails to accept the allotment of a residential accommodation within eight days from the date of allotment of the said accommodation, or fails to take possession of the accommodation within five working days from the date of receipt of the acceptance letter, she /he shall be debarred to apply for accommodation for a period of three months from the date of

non-acceptance of allotment subject to payment of one month's licence fee for that type of accommodation.

2. The date of non-acceptance of allotment shall be calculated from the date of allotment.
3. If an allottee occupying a lower type of accommodation refuses to accept the offer of an accommodation of the type for which she / he is eligible under these rules, she / he shall be permitted to continue in the previously allotted accommodation. It is mentioned that such allottee shall not be eligible for another allotment for a period of six months from the date of non-acceptance of such allotment.
4. The allottee is to deposit security money as per applicable rule for new electricity connection in respect of the quarter under bulk supply scheme. Energy charges including arrears at rates revised from time to time basing on the tariff revision by the Distribution Company will be deducted from the salary and allowances of the employee for allotment of a quarter covered under the bulk-supply scheme. Water charges and any other dues will also be recovered from him at the applicable rates.
