The forenoon of 21.09.2026, being the first day of the internship, shall be utilised for an orientation session with the **HOD, Accountant General (Audit-II), Bihar, Patna**. The internship shall conclude on **30.10.2026** with a final presentation by the intern before the concerned officers, followed by submission of the prescribed internship outputs. A certificate regarding successful completion of the internship shall be issued, subject to satisfactory completion of the internship and fulfilment of the requirements prescribed under the CAG Internship Scheme.

Shri R. P. George, Dy. Accountant General, shall act as the **Mentor** for the internship programme. The Mentor shall guide and review the internship programme and make arrangements for the intern's attachment to the respective

sections.

The intern shall **report to the Mentor on a weekly basis** for review and guidance regarding the internship programme. He shall also report to the concerned section at the commencement of each attachment and maintain the prescribed attendance and learning record in accordance with the CAG Internship Scheme. The detailed activities and assignments during each attachment shall be decided by the concerned Mentor/Section, keeping in view the objectives of the Internship Scheme. The detailed provisions relating to mentoring require the mentor to plan the attachment, arrange relevant sittings and reading material, and record the assessment for the attachment.

The internship shall be governed by the terms and conditions contained in the **CAG Internship Scheme for field offices of IAAD**, including provisions relating to attendance, confidentiality, access to official records/information systems and return of official material. The intern shall maintain a minimum of **75% attendance** and mark In/Out time on a daily basis.

The internship shall be **unpaid** and shall not confer any claim to employment in the Indian Audit and Accounts Department.

A certificate regarding successful completion of the internship shall be issued subject to satisfactory completion of the internship and fulfilment of the requirements prescribed under the CAG Internship Scheme.
