Preface

Forest & Wild Life Department is an important constituent of the State Administration. Drawing and Disbursing Officers play an important role in exercising necessary controls over expenditure & realization of revenue. To enable the Drawing and Disbursing Officers and Controlling Officers to discharge their obligations properly, rules and regulations have been framed and manual has been prepared. Annual Review on the working of Forest and Wild Life Department is prepared every year after reviewing Accounts of the divisions and offices of the department that maintain initial Accounts.

The Annual Review for the year 2024-25 highlights omissions/irregularities noticed in maintenance and compilation of the Monthly Accounts of Forests Divisions and Wild Life Department namely delay in submission of Monthly Accounts, outstanding balances under Forest Remittances i.e. Remittance into treasuries, non-adjustment of Forest Advances, un-encashed/time barred cheques, reconciliation of Accounts and audit observations raised by the office of the Principal Accountant General (Audit), Haryana, Chandigarh.

I hope that the State Government and the Forest and Wild Life Department will promptly address the omissions and irregularities highlighted in the Review so as to improve the system of maintenance of Accounts in the department.

Suggestions to enhance the usefulness of this Annual Review are welcome.

Introduction

The Forest Divisions submit compiled Monthly Accounts to the office of the Principal Accountant General (A&E) for preparation of Monthly and Annual Civil Accounts of the State Government. These Monthly Accounts mainly include Cash Account, Classified Abstract of Revenue and Expenditure, Abstract of Contractors' and Disbursers' ledgers and Schedule of Remittances into Treasuries. The office of the Principal Accountant General (Audit) Haryana conducts the audit of these Divisions and Circles.

The accounting transactions of Forest Departments include receipts and payments under various relevant heads. The financial, accounting and administrative rules and procedures to be followed by the Forest Departments have been elaborated in Departmental Financial Rules, Account Code Vol.-III and Manuals of the Department. Any deviation from these rules and procedures by the Forest Department authorities adversely affects the process of financial accountability.

The review is related to deficiencies noticed in maintenance of initial and subsidiary accounts that are rendered to the O/o Principal Accountant General (A&E), Haryana for preparation of Monthly Civil Accounts. The aim of the annual review on the working of the forest department is to highlight the irregularities in the preliminary accounts. It would help the Departmental Officers to avoid the recurrence of such omissions and irregularities in future. It also improves financial administration and ensures preparation and submission of error-free accounts to this office well in time by the Forest and Wildlife Department.

It is, therefore, imperative that the Forest Department exercises essential controls with necessary checks and balances in place to ensure that the accounts reflect true and fair picture of

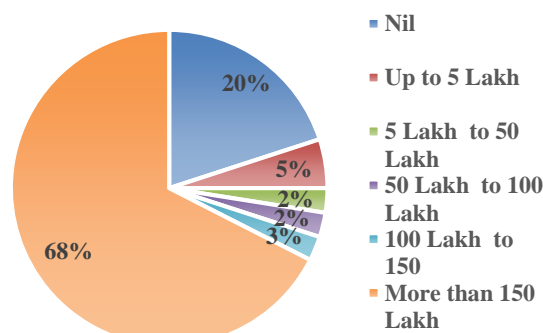
the state of affairs of the Department. The documentation maintained by the Department should validate the truthfulness of execution and expenditure incurred. It should present the details with utmost transparency and clarity.

The Forest and Wildlife Department has 40 forest divisions as on 31.03.2025. The list of forest divisions with their circle code is placed at Annexure-I.

Revenue and Capital Expenditure of the Forest Department

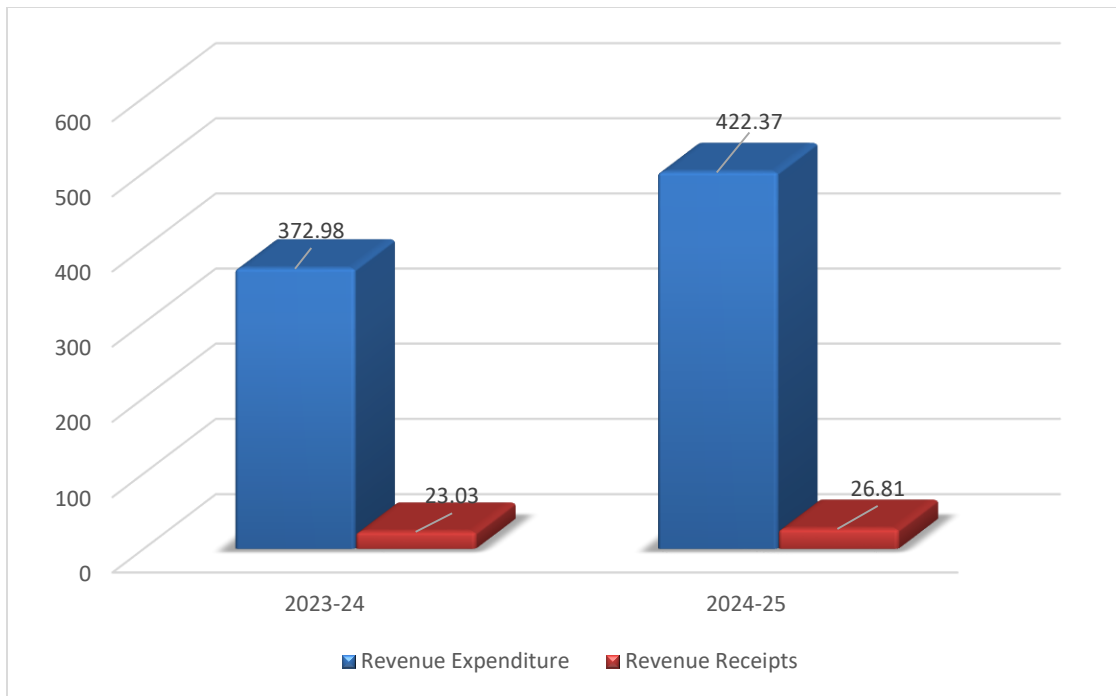

The Annual Review consists of two parts. **Part-1** deals with omissions and irregularities noticed by the Principal Accountant General (A&E) while compiling the Monthly Accounts. **Part-2** contains a summary of audit observations raised during audit by the Principal Accountant General(Audit) Haryana.

Part 1

1.Omissions/Irregularities noticed during receipt and compilation of Accounts

1.1 Outstanding differences under Forest Remittances into Treasury

As per Articles 284 and 288 of Account Code Vol. III, every Divisional Officer prepares the Schedule (Form FAC-15) of amount of Remittances into Treasury and sends it to the O/o Principal Accountant General along with Monthly Cash Account. The said Schedule should be supported by reconciled Consolidated Treasury Receipt duly certified by Treasury Officer concerned. However, it was observed that the Divisional Officers did not send reconciled Consolidated Treasury Receipt to O/o Principal Accountant General resulting in accumulation of differences between the figures of Forest receipts booked by the Forest Divisional Officers and Treasury Officers.

Details of progressive Debits amounting to **Rs.13.89 Crore** and progressive Credits amounting to **Rs.14.72 Crore** on account of Remittances into Treasury by the Divisional Officers which remained unadjusted up to March 2025 are shown in the Annexure-II. Age-wise analysis of outstanding Debit and Credit under Major Head **8782-103-99 Remittances** as on **31/03/2025** is shown in Annexure-II (A).

The matter was pointed out during the annual review last year also, nevertheless, no response has been received till 30th June 2025.

Recommendation: *Necessary instructions need to be issued to the Forest Divisional Officers to ensure that they submit the reconciled Consolidated Treasury Receipt, so that outstanding differences under Remittances can be cleared and it is also recommended that the division should have read-only access of e-GRAS, enabling them to reconcile their figures with the treasury's records. This will improve the process of reconciliation and prevent any further increase in outstanding balances.*

1.2 Adjustment of advances outstanding under M.H. “8550-101-Forest Advances”

According to Article 250 of Account Code Vol.-III, Divisional Officers grant advances for incurring expenditure towards payments to be made by their subordinate offices for the work

executed by them, which are debited as Advances in the Cash Accounts of the concerned Forest Divisional Officer. After making such payments, these advances are adjusted against the appropriate Head of Account. However, advances amounting to **Rs 0.25 Crore (Debit)** are pending for adjustments and there has been no change in the outstanding balance **w.e.f. 31.03.2019**. No action has been taken by the Divisional Officers to adjust the outstanding amount against their division. The Division wise break up of outstanding amount up to the end of the year 2024-25, is shown in Annexure-III.

The matter was observed during the annual review of last year as well. However, to date, no response has been forthcoming till 30th June, 2025.

Recommendation: *There is a need to issue strict instructions to the Divisional Officers to get these advances adjusted at the earliest, or if, this is not adjustable, then this amount may be recovered immediately from the concerned officer/official.*

1.3 Huge amounts of Cheques expired or lying un-encashed

Although Electronic Payment System (E.P.S.) has replaced the cheque system with effect from 1st April, 2013, yet old cheques are still lying outstanding in the books of O/o Pr. Accountant General. It was observed that adequate steps were not taken by the concerned Forests Officers to get these cheques cancelled or encashed. Details of outstanding amount of **Rs 1.52 Crore (Credit)** and **Rs 0.62 Crore (Debit)** are shown in Annexure-IV. Age-wise analysis of outstanding debit and credit under Major Head 8782-103-98/93 Cheques/EPS as on **31/03/2025** is shown in Annexure- IV (A).

The matter was raised during last year's Annual Review also. However, no response has been received till 30th June, 2025.

Recommendation: *Strict instructions need to be issued to all the Divisional Officers to make the entry of cancelled cheques in Cash Accounts immediately of all expired cheques and ensure reconciliation with O/o Pr. Accountant General (A&E) for adjustment of the outstanding amounts.*

1.4 Reconciliation of Accounts

Government of Haryana, vide instructions issued from time to time, directed all the Departments to reconcile their Monthly Accounts with the O/o Pr. Accountant General. The reconciliation work is currently being handled at Headquarters level i.e. O/o PCCF, Haryana on Monthly basis but the issues of divisions remain unresolved even after reconciliation process. This results in mismatch in expenditure & challan data reported by the Department and booked by the O/o Pr. Accountant General. The issue was observed during the annual review last year also. However, no response has been received till 30th June, 2025.

Recommendation: *The State Government may issue suitable directions to the C.C.Os of the Department, emphasizing the need for reconciliation of their accounts every month with O/o Pr. Accountant General to guard against misclassification, wrong payments, frauds and embezzlements.*

1.5 Accounting procedure for Compensatory Afforestation Fund Management and Planning Authority (CAMPA) not being followed

According to the Compensatory Afforestation Fund Act 2016, the State Governments are required to establish the State Compensatory Afforestation Fund under the Public Account of the State which would be managed by State Authority to be called 'State Compensatory Afforestation Fund Management and Planning Authority'. The Authority would administer the amount received from the User agencies towards Compensatory Afforestation, net present value and all other amounts recovered from such agencies under the Forest (Conservation) Act, 1980. The money collected shall be utilized for undertaking artificial regeneration (Plantation), assisted natural regeneration, protection of forests, forest related infrastructure development, Green India Programme, wildlife protection and other related activities and for matters connected therewith or incidental thereto.

The detail of State Compensatory Afforestation Fund Account (8121-129) as on 31st March, 2025 is as follows: -

*Amount of Rs.50.13 Crore for the year 01/04/2022 to 31/03/2023 and Rs.107.37 Crore for the year 01/04/2023 to 31/03/2024 and 01/04/2024 to 31/08/2024 deposited by the user agencies in the CAF was transferred from National Compensatory Afforestation Deposits under 'Major Head 8336 Civil Deposit' to State Compensatory Afforestation Fund, Haryana under 'Major Head 8121-General and other Reserve Funds'.

As per Compensatory Afforestation Fund (Accounting Procedure) Rules 2018, the receipts relating to Compensatory Afforestation which are received by States and Union Territories from the User agencies will be credited in the first instance in Minor Head '103-State Compensatory Afforestation Deposit' under Major Head '8336-Civil Deposits'. Various activities viz. Compensatory Afforestation, Net Present Value, Protected Areas etc. will appear at Sub Head level in Minor Head '103-State Compensatory Afforestation Deposits.'

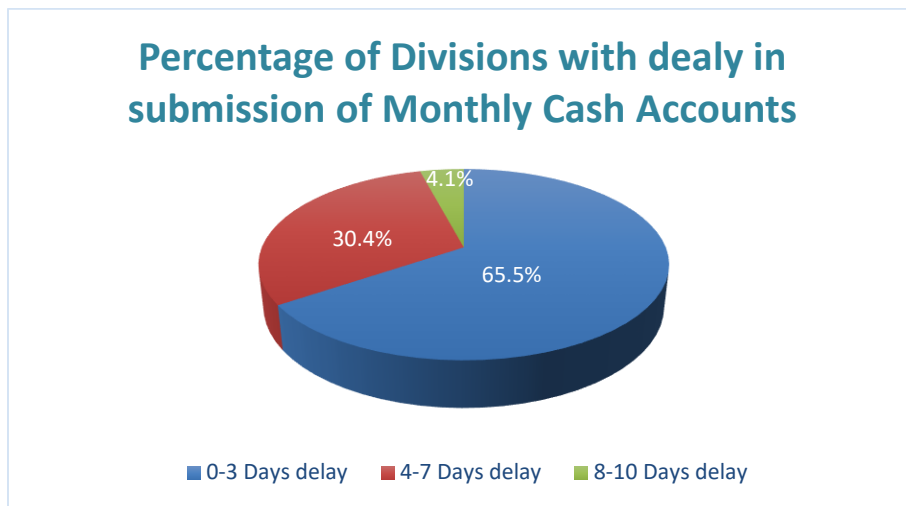
Thereafter, 10% of the balance remaining under '8336-Civil Deposits' shall be transferred to the National Fund by the States and 90% to '129-State Compensatory Afforestation Fund (SCAF)' below Major Head '8121-General and other Reserve Funds.' However, the State Government is not following prescribed accounting procedure. No amount has been credited in Minor Head 103 State Compensatory Afforestation Deposits under Major Head '8336-Civil Deposits' by the State Government for the year 2024-25.

Recommendation: Necessary directions may be issued to the department to follow the prescribed accounting procedure by operating Major Head '8336-Deposit' for transfer of all amount received from the User Agencies to the Fund.

1.6 Delay in submission of Cash Account

In accordance with Article 288 of Account Code Vol.-III, it is mandatory for all the divisions of the Department to submit their accounts by 5th of the following month to Principal Accountant General (A&E) office. Article 292 of Account Code Vol.-III, provides that for special reasons, the

Divisional Officer may authorize a few days' delay in the submission of accounts, but if they are not dispatched on or before the 10th of the following month, the reason for the delay must be intimated invariably on that date. However, it was noticed that during the year 2024-25, various divisions did not submit their respective accounts on due dates. Annexure-V shows total number of times respective division has submitted accounts with a delay and Annexure-V(A) shows duration of delay in receipt of Cash Account from Divisions. The abstract of delay is also given below :-



There are also instances where the detailed accounts have not been submitted by the divisions (Annexure-VI). Delay in submission of accounts affects timely compilation and submission of Monthly Civil Accounts by O/o Principal Accountant General (A&E) to the State Government. Even after the issuance of various requests by this office to Principal Chief Conservator of Forests, Haryana, there was delay in submission of accounts.

Recommendation: *Timely submission of Monthly Accounts by all divisions may invariably be ensured.*

2. Computerization of Forest Accounts

All the Forest Divisions have been fully computerized and Monthly Accounts of Forest Divisions are received via e-mail or pen drive in the form of text files every month. The text data received from Divisions is uploaded in the Forest Module of Voucher Level Computerization (VLC) software and the same is fetched during the posting of Monthly Accounts.

However, while receiving the Monthly account text files from the divisions, many discrepancies have been noticed such as incorrect circle code and division code, incorrect nomenclature of file due to which data could not be utilized for uploading in the VLC module and accounts have to be posted manually.

Additionally, since the account month of December 2024, the concerned divisions have completely stopped submitting the text data files. Despite the matter being taken up with the Principal Chief Conservator of Forests, Haryana, the files are still not being submitted.

Non submission of text data files or submission of files with incorrect codes or nomenclature leads to delay in posting and late submission of Monthly Civil Accounts by O/o the Principal Accountant General (A&E) to the State Government.

Recommendation:- *Necessary directions may be issued to all Divisions to send text data file every month in VLC compatible format and with correct codes & file nomenclature.*

Part 2

3. Outstanding Audit Inspection Reports/ Paras

There are 195 Audit Inspection Reports containing 654 **Audit Paras** with cumulative amount of **Rs.934.42 Crore** pending against the Department (Annexure-VII).

Irregularities of Common nature which have been noticed during Central Audit of Forest Divisions are: -

- (i) Non-marking of numbers on Running Bills.
- (ii) Payment on Proforma Invoice instead of Original Bill.
- (iii) Paying Bills in pieces and in small amount even of tenders, works.
- (iv) Non-deduction of TDS under Section 194 J of IT Act, 1961.
- (v) Non- deduction of labour cess from construction related works.
- (vi) Non-furnishing of Stock entry of purchased items.
- (vii) PAN number, Work Order number, tender numbers and vouchers numbers not shown on bills.
- (viii) Non-furnishing of utilization certificate of items purchased.
- (ix) Payment of bills by all officials and officers including contractors without signing dates.
- (x) Not writing of voucher number on paid bills/ payment vouchers attached with the detailed accounts.
- (xi) Showing miscellaneous expenses instead of expenses on works/items in vouchers.
- (xii) Sending the work payment bills of the previous month along with the detailed accounts of current month.

Irregularities of significant nature which have been noticed during local audits of Forest Divisions are: -

- (i) Unauthorized withdrawal of government funds from the treasury and obstruction and misappropriation of funds.
- (ii) Non-utilization of funds received under State Compensatory Afforestation Fund and School Eco Club Scheme.
- (iii) Unauthorized compensatory afforestation/non-transfer on non-forest land for

compensatory afforestation.

- (iv) Delay in preparation of Annual Operations Plan/ Lack of meeting of Governing Body, Steering Committee and Executive Committee.
- (v) Inordinate delay in setting up of 'Swarna Jayanti Environment Training Institute'.
- (vi) Non-receipt of utilization certificate.
- (vii) Departmental Recovery not effected against Employees/Officers
- (viii) Non-receipt of full failing charges from the user agency in case of diversion of forest land.
- (ix) Non- planting of trees on CA sites already approved under the Forest (Conservation) Act, 1980.
- (x) No action by Forest department against those who destroy plantations.
- (xi) Non-recovery of interest on outstanding amount released by Haryana Forest Development Corporation Limited.
- (xii) Non-deduction of TDS on payment of fees and non-collection of water cess.
- (xiii) Non-collection of royalty fees for fallen trees.
- (xiv) Non-disposal of pending cases of violation of Forest Act.
- (xv) Inordinate delay in construction work in Herbal parks.
- (xvi) Loss due to non-claim of interest on advance payment made to Haryana State.
- (xvii) Agricultural Marketing Board - Non-disposal of logs laying within ranges.

DFO, Morni Pinjore Division has the highest number of outstanding paras (47) while State Compensatory Afforestation Fund Management and Planning Authority Haryana State, Panchkula (CAMPA) has the paras with maximum value in monetary terms (Rs. 347.31 crore). It is relevant to mention here that like the previous years, the pace of settlement of outstanding Inspection Reports/Paras was found very slow during the year 2024-25.

Recommendation: *Necessary directions for early compliance to audit observations and settlement of the outstanding paras need to be issued to all Divisions.*
