Sub: - Mandatory Training to AAOs to be empanelled for promotion as SAOs for the panel year 2024.

As per the revised recruitment rules for Sr. Accounts Officer/ Sr. Audit Officers, the eligibility criteria for promotion to the post of Sr. Accounts Officer / Sr. Audit Officer is Assistant Accounts Officer / Assistant Audit Officer in Level-8 (₹ 47,600-1,51,100) of the pay matrix with seven years of regular service including service rendered in non-functional grade of Level-9 (₹ 53,100 – 1,67,800) of the pay matrix and having successfully completed mandatory training of two to four weeks in the field as prescribed by the department.

In view of this and as per Headquarters letter No.420/Trg. Div./373/2019 dated 24.09.2020 the following schedule is made:-

- i) Three weeks mandatory training is to be conducted from **11.05.2023** to **31.05.2023** as per the programme (Annexure) in the Training Hall of Main Office, Bhubaneswar.
- ii) The training is to be conducted In-house through SAI Training including nomination. Candidates are required to register themselves by logging into SAI Portal and feedback on each session may be given accordingly till the completion of the training.
- iii) The end of training examination is going to be held on <u>07.06.2023</u> from 11.00 AM to 01.00 PM in the Training & Exam Hall of Main office. The minimum benchmark of the examination is 45% as fixed by the headquarters.
