NOTICE INVITING TENDER

This office intends to procure three television sets (as per the specifications below) from reputed supplier. Intended bidders are requested to quote their rates subject to fulfillment of the terms and conditions stated below:

A. General Terms & Conditions:

- i. The bidders should have valid GST registration and PAN Card.
- ii. The selected firm would be required to supply the television sets in the Office of the DGA(Coal), Kolkata on specified date and time.
- iii. The rate quoted should be valid for a period of (06) six months from the date of the quotation.
- iv. The firm should be in a position to supply the items on very short notice as and when required.
- v. The owner or authorized person of the firm should be available on his direct telephone and also on mobile phone.
- vi. The work order would normally be awarded to the lowest evaluated bidder whose bid has been found to be responsive and who is eligible / qualified to supply the products as per the terms and conditions incorporated in the tender letter.
- vii. The rate quoted by the bidders must include GST & delivery charge. No extra payment would be made in the form of GST or delivery charge. No charges / escalations in the accepted rates would be entertained.
- viii. Quality of the product should never be compromised. In case it is found at any stage that the quality supplied is inferior or of brand other than that specified, the Contract would be treated as *void ab initio* and the Firm would be blacklisted. No compensation would be paid for rejected stock / items supplied, for any reason whatsoever.
- ix. The Tenderer would be responsible for delivery of goods at specified location in *good* condition at his own risk and cost. The supply is to be made as and when required.

- x. All matters / disputes pertaining to the tender and resultant contract would be settled by the Director General or an Officer nominated for the purpose. However, decision of Director General or the Officer nominated by him would be considered as final.
- xi. The bidder should enclose a signed copy of the terms and condition stipulated for award of the contract conveying his acceptance of the same.
- xii. The bidder would not to be allowed to sublet supply of any item (partially or entirely) to any other firm without permission of this office.
- xiii. This Office reserves the right to reject any or all quotations without assigning any reason.
- xiv. No advance would be paid for supply of items. After satisfactory completion of work or delivery of items, the vendor may submit bills / invoice for payment.
- xv. For detailed information and further clarification, the intending bidders may contact the SAO / Admin. of this office on any working day within the stipulated date of submission of quotations.
